Historical Corrections and Payroll Processing

What are historical corrections and historical edits?

A historical correction is an adjustment to an employee's totals record that reflects a difference in hours, pay, or both. Historical corrections are caused by a historical edit (some change made to an employee's time record, in a signed-off time period, that impacts their totals). Historical corrections are needed for historical edits because the pay periods the edits occurred in have already gone through payroll processing. You can use the historical corrections to determine whether and how to process the difference in hours or pay for employees in the next payroll process.

When do historical edits occur and how do I resolve them?

While there are times when it is very clear when historical edits have occurred (for example, editing a timecard in a signed-off period), there may be instances when historical edits occur, resulting in pending historical corrections, that are not so obvious and may impact payroll processing, such as:

- An update to a person record that impacts totals for a signed-off period
- An update to configuration that impacts totals for a signed-off period
- Fixes introduced in a software update (rare)

The RequestAPI Task was enhanced to add the missing properties to its response.
- WFD-110638** Even though a user's Function Access Profile was set to disallow Known IP Address Ranges, the Known IP Address option displayed in **Administration > Application Setup > Common Setup**.
- WFD-110302** When a user added a Report Data Object to a custom report, the following error occurred:
"WCO-106163 : Unable to retrieve specified employee [number] for the selected timeframe. Possible causes: employee is inactive or the incorrect employee-ID is specified."
- WFD-109821** In the Batch Job List setup application, the dates and times listed in the Launch Date selector for a job did not correspond with those listed in the job's date range display.
- WFD-109557** While applying an express upgrade, some nodes became stuck on services and did not proceed until restarted or when a new node was launched.
- WFD-109229** If the Tenant Management System (TMS) went offline during a tenant cleanup, the Private DNS mapper component was put in a failed state. When the cleanup operation was retried, the tenant router reported a "404 Not Found" error and the TMS listed the following error:
"PrivateDNSMapper failed to clean up. Bad - SiteURL deletion in Private DNS failed".
- WFD-105997** When employee assigned a delegated role with correct system administrator and display privileges ran the Audit Report, the report showed no data.

"WFP-01298 An unexpected non-SQL system error has occurred. Please contact your system administrator. The system log file may have more detailed information that will require to troubleshoot this issue."
- WFD-110843** The locations listed in the Worked column in the Float report did not appear to be correct.
- WFD-110622** When a shift that was assigned to a schedule pattern had a comment with a note attached, any subsequent updates to the note that were made when editing the schedule pattern were not

retained and the original note was still displayed in the Schedule Planner.

- WFD-110377** The Schedule Group Profile Assignments API resource (operations against `/v1/commons/persons/schedule_group_profiles`) has been enhanced to allow the caller to specify "Empty" as well as "Empty Profile" to remove assignments. This allows the caller to use the same word shown in the Dimensions UI when unassigning Schedule Group Profiles.
- WFD-110036** In the Employee Schedule - Weekly report, employees that had the same name were displayed in one row that combined their schedules instead of each employee's schedule being displayed in a distinct row.

"Configuration issues (invalid hierarchy, incorrect timeframe, or authorization) are preventing access to this Dataview. Contact your administrator to modify the Dataview configuration."

- WFD-109899** After a Procedure Set was selected in the Call List, the progress indicator did not display in the UI and users did not know whether the Procedure Set was running or not.
- WFD-109853** The Employee Schedule - Weekly report showed incorrect locations for employee transfers which resulted in employees receiving incorrect information about where they were working.
- WFD-109812** The user created a Business Structure Dataview. When the Dataview was opened for a specific location, the following message appeared:
"Information Data within Actual Hours Per Volume, Schedule Metrics (Location) can not be retrieved. Contact your System Admin."
Data was not populated as expected.
- WFD-109798** In Schedule Planner, the Audit Tab displayed as blank when multiple employees or a location was selected. Data was only being displayed in the Audit tab when a single employee was loaded in Schedule Planner.
- WFD-109549** When a Visibility Period was configured to open the Submission Period at 12AM UTC, the Visibility Period actually opened at 7PM EST, which let employees start self scheduling too early.
- WFD-109512** The online help for automatically assigning breaks when adding and editing shifts incorrectly stated that a warning message would display – indicating that the automatic break placement would override the manual break placement – if a break was added manually when the Assign Breaks option was selected.

- WFD-107081** The Request Subtype Transitions business process did not work with the Approved to Cancel Submitted transition or the Cancel Submitted to Cancelled transition.
- WFD-104310** The Update Schedule for Multiple Employees (POST `/v1/scheduling/schedule/multi_update`) API operation would not generate a correct partial success response body (when the optional `partial_success` Boolean was set to 'true') when an incorrect shift segment type was specified in the request payload.
- WFD-6855** When a Paycode edit was added to a employee's schedule from Schedule Planner and the employee's status was set to "Unavailable," the subsequent removal of the edit did not reset the status to "Available."

Timekeeper

- WFD-110663** When viewing employee timecards, after selecting the Totals tab and then using the arrows to navigate to the next employee's timecard, the following error message was received:
"Please provide Employee information to select timecard data."
- WFD-110498** The Bulk Accrual Reset (POST `/v1/timekeeping/accruals/resets`) API operation

intermittently failed with an HTTP status code 400 error. The root cause was identified and corrected.

- WFD-110299** In the timecard, after changing a duration Paycode with a work rule transfer to a different duration Paycode with a work rule transfer, the transfer did not update.
- WFD-110228** The Create or Update Persons (POST /v1/commons/persons/multi_upsert) API operation did not accept employee hours between 0.01 and 1.0. This operation now accepts all employee hours greater than 0.01.
- WFD-110175** In certain circumstances, the Retrieve Schedule (POST /v1/scheduling/schedule/multi_read) API operation returned a Null Pointer Exception error. The root cause was identified and corrected.
- WFD-110134** When logged in to an English UK locale and editing an Overtime Rule using the "Specified Number of Days" reset, after changing the reference date and saving, the date format was incorrectly changed to the US date format.
- WFD-109946** In Schedule Planner, after adding an open shift that included a Labor Category transfer and then attempting to view the Call List to find a replacement for the shift, the list was empty and the following error appeared:
"There are no items to display."

Platform

[WFD-109556](#) **All Home and Scheduled In** hyperfinds were returning employees who did not have a transfer. When a manager uses this hyperfind, he should only be able to see employees belonging to his home location and employees having scheduled transfers to his home location.

Scheduling

[WFD-110597](#) that were assigned to Schedule Patterns had days that were not populated after shift builder ran. All shifts configured in schedule pattern should have been populated in schedule planner.

Timekeeping

[WFD-114685](#) After timecard sign-off, there were missing accrual Pay codes from the "Timecards Totals" add-on.

[WFD-113870](#) Corrections were being duplicated for multiple employees after enabling edit. This is related to issue WFD-107395.

R7 Update 3, Express Upgrade 5

Forecasting

[WFD-111706](#) When the Volume Forecast engine was run on a location, a volume was generated even when that location was configured as Closed in the Hours of Operation Override.

Normally, recalculation should produce the same result. In some cases, however, the user-entered labor account was removed from shifts and the transfer was lost, resulting in a historical correction.

Key Performance Indicators (KPI)

WFD-112102 When attempting to run a Historical Load, the following error was encountered: "*Error Running Historical Load The Historical Load process has completed with errors for the following objects: OT_HRS.*"

Platform

WFD-110708 The Accruals available balance in the smart tile was not the same as the available balance in the timecard.

Scheduling

WFD-111630 If employees self-scheduled themselves with a transfer shift, when they submitted the Self Schedule Request, all transfer shifts were disassociated with the Self Scheduling Request and were committed to the schedule. If the employee then edited their self schedule request, they could not remove the transfer shifts.

[WFD-109516](#) When an employee was terminated and the termination date was TODAY's date, any non-signed activity data was deleted and was not saved to the database.

[WFD-112434](#) When attempting to open the calendar and trying to put in a request for self-scheduling or an Open Shift Request, the following error occurred: "*Error Some Unknown Error Occurred. Error Details Not Available.*"

[WFD-111574](#) In Schedule Planner, a manager entered a Time-off Request (TOR) for a first Half Day successfully. The time length of the TOR and the remaining portion of the shifts were correct. However, when they entered another TOR for the same day for the second Half Day, the resulting shift length was short by 7-8 minutes. The behavior only affected the last TOR entered.

[WFD-111252](#) Organizational Rule Sets were preventing employees from being able to self-schedule.

[WFD-110892](#) An incorrect Labor Category was displayed in the timecard.

Universal Device Manager (UDM)

[WFD-112715](#) On a repeated basis (that was not clock-dependent), when users attempted to use the ATK Smart View out-punch softkey, there was a delay of 4+ seconds, from when the ATK Meal message was answered at the device to when the '*Transaction successful*' message displayed. [WFD-112304](#) Shift Swap requests did not return any results due to Organizational Rule Set violations from

other employees who did not have the Skill required but were scheduled in the same location.

WFD-109180 When attempting to cherry-pick select Business Structure locations from UAT to PRD, the following error appeared:
"The expiration 1/01/3000 of location WF must end on or earlier than its parent expiration date 1/15/2021".
All Locations appeared to have the same error, though the expiration date changed.

WFD-109052 A pattern availability was not applied to a schedule, and the following error appeared:
"WFS-113601 AvailabilityExceptionFactory:RECORDS_NOT_FOUND error".

Timekeeping

WFD-112239 Broken pipe errors were appearing for an affected database.

WFD-110032 In the Actual vs Schedule by Job report, the variance wages were not calculated correctly. The variance hours were negative for overtime paycodes, and there should have been negative variance wages as well.

WFD-103578 Attempts to migrate a business structure from one tenant to another failed with the following error:

"Some Internal Server Error Occurred. Please contact System Administrator."

WFD-100466 A REST API has been added for updating static driver assignments.

Previously, static driver assignments did not have an API to update an existing assignment. For updates, this required users to delete and then re-add static driver assignments.

Information Access

WFD-108479 The Time Series Dataview data was not in sync with actual data after the user's environment was refreshed.

WFD-106543 When "Per Pay Period" hours were entered into an Employee's Person Record for minute values in either HH:mm or HH.mm format, the column showed the number as a full precision decimal instead of rounded to two decimal places in Schedule Planner or a Dataview.

Integration Hub

WFD-107369 When users created a copy of an integration set, it did not run as scheduled and failed.

WFD-105062 The Payroll Based Journal (PBJ) Export integration did not generate the export file when it ran for multiple facilities, and any of those facilities did not have employees in the Hyperfind. Users had to run the integration individually for each facility. Now, the integration runs for all facilities, including facilities that have no employees, but it generates a message that no records are generated for those facilities without employees.

WFD-11569 Leave time could not be added to a Leave Case for specific employees after an accrual error.

WFD-108752 Attempts to edit attestation workflows intermittently failed with a "400 Bad Request" error.

- WFD-108205* Attempts to delete a workflow notification from Application Setup > System Configuration > Workflow Notifications failed with the following error:

- WFD-102675** Daily Coverage in the Schedule Planner was not being updated when holiday assignments were changed in a location profile.
- WFD-102090** The Location Schedule - Weekly report had formatting issues that resulted in an increase in the number of pages in the report.
- WFD-101936** Notifications in Control Center for shift swaps were not consistent with the locale policy for the current user.
- WFD-101305** Processing times for Schedule Generation tasks were not being accurately recorded in the Batchjobtask table.

WFD-10140, DIM-200793 The Retrieve Time Off Requests as Manager and the Retrieve Time Off Request by ID as Manager API operations (POST /v1/scheduling/timeoff/multi_read and GET /v1/scheduling/timeoff/{timeOffRequestId}) have been enhanced to add an 'includeOverriddenShifts' request property and an 'include_overridden_shifts' query parameter, respectively. These new Booleans allows the caller to include overridden shifts in the response.

WFD-9708 An Hours of Operation column is now provided to be used in Schedule reports and show store hours for selected days.

Timekeeping

WFD-109701 When attempting to use SDM to import a new custom report, the import failed.

WFD-108720 After resolving Must Fix exceptions from the Manage Timecards tile, the number in the Must Fix category was reduced as expected, but the number in the Timecards with No Exceptions did not increase as expected.

WFD-108513 The Duration (Hours) and Money Amount columns in Dataviews were showing rounded values when a paycode edit was made in a employee's timecard. They should have shown the actual values that were displayed in the timecard.

WFD-108313 When entering wages for Override Wage & Work Rules, even though the currency decimal precision of the user's locale was set to 5, when a wage with 5 decimals (34.25467) was entered, it was rounded to 2 decimals (34.25000).

WFD-108289 The Update Attestation Profile Assignments by Person Number API operation (POST /v1/commons/persons/attestation_profile_assignments/multi_update) would incorrectly throw a 500 Internal Server Error response if an effective date after the system-default "forever date" of 3000-01-01 was specified, preventing 207 Partial Success processing. The operation now provides graceful error handling of "after forever" effective dates.

WFD-108258 When attempting to open a specific employee's timecard, the following error was received:

"A System Error was encountered during CT Call."

In addition, the employee was not totalized.

"Request timed out waiting for the server to respond."

[WFD-105986](#) Attempting to press 'Download File' on a badge format that was imported into UDM using SDM did not prompt to download the file.

[WFD-109855](#) When users navigated to My Apps, an error appeared stating that the App Key did not exist. App keys had previously been created.

"Aggregation input data has some errors".

WFD-110475 Could not assign Employment Terms from the People Editor

WFD-112015 When selecting certain Procedure Sets for Call List, they are failing with the following error:

"Some Unknown Error Occurred. Error Details Not Available."

The error should not have occurred, the employee list should have populated, and the error message was not helpful.

Timekeeping

WFD-110059 When accessing the timecard Accruals tab for certain employees, a "No data to display" error appeared. When attempting to RESET ACCRUALS in the timecard for these employees, an error appeared stating that the employee did not have an accrual profile assigned.

days in the period after the termination. The calculation was keeping the last post-termination day.

Scheduling

WFD-111074 The Schedule Generator Offset `/W:1` was not generating schedules for the next week.

- WFD-111030** When running weekly schedule generation batch job for several stores (about 250), there had previously been a few stores that failed each week which could be corrected and resubmitted. Every few weeks, many stores (for example, 150) failed for unknown reasons.
- WFD-110393** Issue: When a Manager (any Manager) selected View by Schedule Group in the Schedule Planner, it took an excessively long time (more than a minute) to fully load.
- WFD-110874** Unexplained historical corrections were generated in the timecard, causing employees to get paid incorrectly.
- WFD-110390** When the Schedule Generator Batch Task Parameter String used */Organizations* with a capital O, the system did not validate the Business Structure path. If a Location was moved in the Business Structure, the org path was not being validated and the Schedule was not be generated.
- WFD-108770** When there was a Request Subtype for Availability Change for employees, and the Request Subtype had a Reminder Template in use, the Request Subtype did not send out notifications to either employees or managers, and could not be approved or rejected. Notifications should still have been sent out, with or without a Reminder Template in place.
- WFD-107107** Group and Manager JTS field values were not displayed or were slow to load under Manager Role-General in People Information.
When they did not populate, "No data to display" appeared in the fields.
When they were just slow to load, it took 10-30 seconds or longer.
- WFD-106588** Schedule Total Hours were not populated on the Call List. For example, when a manager ran the Call List for shift on a specific date and expanded the Employee Details, the Schedule Total Hours column was not populated, but the Scheduled Total Hours was populated in Schedule Planner.

Timekeeping

- WFD-110869** In the timecard, Target Hours were displayed as zero for the previous date pattern after making historical corrections.
- WFD-109403** Users were unable to save timecards with pending historical edits. This was causing an inconsistency of data between the timecard and what the API was returning.
- WFD-109357** Clicking on the Accrual add-on in the timecard view resulted in an error, and this also impacted the ability to submit Time-off Requests (TORs).

[WFD-108978](#) Historical corrections were regenerating for a specific employee, instead of only being generated once.

[WFD-107395](#) Historical corrections were duplicated for multiple employees after enabling edits.

UDM

[WFD-109942](#) Devices and Profiles were missing in the configuration view (Device > Configuration), but were visible on the dashboard.

Work

[WFD-109857](#) running an integration which called the `v1/work/activity_totals/multi_read/` API, the API call returned HTTP 500 errors. However, the Splunk and Process Reporting logs did not provide additional information.

R7 Update 2, Express Upgrade 6

The issues below were resolved for the R7 Update 2, EU 6.

Scheduling

[WFD-110715](#) Null comment was returned when requesting a shift swap. This is related to Issue [WFD-110068](#) (below).

[WFD-110068](#) When an employee attempted to swap shifts for future dates (months in advance), the Shift Swap panel failed to find any employees to swap shifts with. Sometimes it was possible to use the Employee filter to locate specific employees, but employees should not have to hunt for other employees to swap with.

[WFD-108836](#) When an employee opened their My Calendar, they immediately receive this error: "The requested shifts: # are not during the request period" and no data showed on their Calendar.

[WFD-108124](#) When employees submitted a Time-off Request with the first half and second half, the system displayed an error when the manager tried to approve the second request.

[WFD-107003](#) Employees who initiating requests via Employee Self Service (open shifts, request to cover, shift swap) were getting tagged for Predictive Penalties even though the Predictive Scheduling Rules had "Exclude employee initiated Self-Service requests" checked.

Timekeeping

WFD-104426 The API `GET v1/timekeeping/setup/combination_rules` was returning combinations that were not set up for the combination rule.

WFD-103899 "Early out" exception was not triggering when shift was less than the shift guarantee configured.

R7 Update 2, Express Upgrade 5

The issues below were resolved for the R7 Update 2, EU 5.

People

WFD-110385 The following error was appearing when using the API `v1/commons/persons/multi_upsert` *PSQLError: ERROR: duplicate key value violates unique constraint "xu1_assignpayrule"*.

Platform

WFD-109170 Managers were unable to view system messages within the Control Center. When accessing the area, the following error appeared: *API-10001 Some internal server error has occurred.*

Scheduling

WFD-109973 The coverage patcher was failing due to invalid parameter variables.

WFD-109972 We have added the ability for the delete patchers to work on a specified list of employee IDs only to rectify the following problem: Business had signed off on a specific list of the employees whose shifts would be deleted by the patchers; however, without specifying employees, new corruption could have been created between investigating their db and running the patcher. This could result in a deletion of more shifts than they have signed off on.

WFD-109149 Batch jobs were failing.

WFD-108252 Performance issue: multiple BGP and API nodes were showing sustained high CPU.

WFD-107353 The following was occurring when a manager created a schedule pattern for an employee: When the manager went back to edit it, there were two schedule patterns showing with the same start date and name. When attempting to edit, delete, or end-date the schedule pattern, an error occurred.

WFD-105131 Employee's schedule pattern was end-dated, but shifts were not properly removed by the patcher.

WFD-102413 Even though there were only 3 days in the accrual bucket "Sick Leave Without Cert Consecutive" for an employee (this is by configuration), the system was allowing the addition of more than 3 consecutive days of "SL-WOC" in the employee's schedule.

Timekeeping

WFD-110739 Self Scheduling was not available to employees in locations that had recent business structure changes.

WFD-110512 When using the All Home Hyperfind in Employee Summary, the correct employees were not displaying.

WFD-109617 When a manager entered time off via a pay code edit for a scheduled day in an employees schedule (selecting the override accrual days option), the hours incorrectly displayed as zero in the timecard.

WFD-108952 Hours in the 'Target Hours' section of the timecard were being doubled. This was caused by there being more than one Employment Term, even though the Employment Terms did not overlap. If the second Employment Term was removed, the target hours were correct (and if manually re-added, they were wrong again).

WFD-108220 Columns in Dataviews were not returning any data. They included "Paycode Total Actual Hours (Include Corrections)" and "Paycode Total Actual Wages (Include Corrections)".

WFD-107555 Latency issue with Totalization when Base Wage import integration was executing. Employees showed totalization status of "1" which did not totalize correctly.

WFD-103070 Job transfer error that the job doesn't exist, or that this user doesn't have access to the job. Example: Job transfer on employee, moving employee's paid time to a different pay code; uses the same Job in the Business Structure as other transfers made during the previous pay period. The job code should be accessible by the manager in the system, but it was giving an error that the job doesn't exist, or that this user doesn't have access to the job.

WFD-102718 Incorrect data was appearing in a custom report for 'Actual Spend by Region'.

WFD-100729 When a Duration Pay Code was added to an employee's Timecard, it was being treated as a new shift which triggered a bonus rule.

R7 Update 2, Express Upgrade 4

The issues below were resolved for the R7 Update 2, EU 4.

Key Performance Indicators(KPI)

[WFD-105857](#) "Error occurred while processing the event" was occurring for forecasting events when labor-based events were received for dates when the corresponding job had expired.

People

[WFD-107844](#) When a manager did a hyperfind that was associated to the employee group in their people record, the hyperfind was "ignored" and all employees displayed.

Platform

[WFD-109384](#) Tenant provisioning was failing due to OutOfBoxTemplate.

[WFD-108752](#) When editing Attestation workflows, an "HTTP status 400 bad request error" occurred intermittently.

[WFD-107009](#) SDM > Publish History page was intermittently failing and displaying a "400" error.

Scheduling

[WFD-103864](#) The dates that employees were seeing in Employee Self Service to request Time Off or Self Schedule were not matching what was defined in the Employee Visibility Period.

[WFD-103733](#) Enhancement to allow managers to perform Labor Category Transfers on visible employees in the Schedule Planner. Prior to this, the schedule editors could not perform these transfers on secondary employees in the schedule planner. Managers can now edit any employee they see in their schedule, regardless of if the employee falls into their default Employee Group.

Timekeeping

[WFD-109944](#) Performance issue: the Punch Import operation was very slow.

[WFD-106969](#) When clicking the Employee Role link on an employee's person record, a "Page Not responding" error displayed. If the user waited, the page would eventually respond. This would occur each time the user selected another employee to view.

WFD-105186 Project View Timecard was incorrectly calculating hours-worked after a paycode edit. When the same paycode edit when made in an Hourly View Timecard, the hours-worked were calculated correctly.

R7 Update 2, Express Upgrade 3

The issues below were resolved for the R7 Update 2, EU 3.

Healthcare Analytics (HCA)

WFD-107446 The Manager Approval Count dataview metric was not accurately reflecting the correct approval counts. This affected many employees in the previous pay period. The KPI / metric should be reflecting the correct amount within a few minutes.

Platform

WFD-107595 For managers, pay period based Workflow Notifications were not being received by all intended recipients

Reporting

WFD-108622 An SDM custom read-only report would not generate and produced a "nullpointer" exception.

Scheduling

WFD-109841 Unable to add transfers to schedule. Users should be able to edit a schedule and transfer some/all of the shifts to a location to which the user has access.

WFD-106290 When an employee opened My Calendar (through the My Schedule tile or through the menu), the schedule did not appear on the calendar and the following error appeared: *Error: Cannot destructure property employeeid of 'undefined' or 'null'.*

WFD-104288 A failure was occurring when creating an EmploymentTerm Schedule Pattern via the API "v1/scheduling/employment_term_schedule_patterns/apply_create". The attempt resulted in the following error messages: *"Some Unknown Error Occurred. Error Details Not Available"*, and *"Transaction silently rolled back because it has been marked as rollback-only"*.

WFD-103837 Error ("*One or more labor category entries could not be found*" or "*You do not have access rights*") appeared with Scheduled Transfer. This was occurring when trying to edit an In-punch or performing "Mark as Reviewed" punch action.

Timekeeping

- WFD-109596* Error "*WCO-112003 null*" was appearing in the Manage Timecard Tile on the home page and also on the Timecard landing page (Employee Summary) when using the Hyperfinds "All Home Transferred In" and "All Home Transferred In."
- WFD-108530* Performance issue: The "*v1/timekeeping/timecard/changes/<<id>>*" request resulted in multiple requests saturating the JDBC connection pool on the originating host.

R7 Update 2, Express Upgrade 2

The issues below were resolved for the R7 Update 2, EU 2.

Scheduling

- WFD-109293* Organizational Sets selection modified "by itself" for multiple tenants. The location selections in org sets should never change without specific modifications.
- WFD-108972* An internal server error when selecting Coverage Counts metric. A "spinning wheel" displayed prior to the error appearing. Reloading resulted in the grid containing all 0s across the board.
- WFD-108961* Approved Time Off was showing in the Schedule, but not in the Timecard.
- WFD-108292* When reviewing the Daily Coverage counts in Schedule Planner or the Staffing Dashboard, the Schedule count for the "RN" job showed 1 Scheduled for several days, even though there were multiple shifts scheduled that met the coverage that day.
- WFD-105985* The following error appeared when attempting to run the schedule generator to generate open shifts only for a single location: "Error Generator failed. Engine exception : Internal error".
- WFD-105070* Performance issue caused by excessive calls to the schedule column values that included the rules violation indicator.
- WFD-104859* The Schedule data patcher was failing in the UAT environment with error RECORDS_NOT_FOUND_BECAUSE_NOT_IN_DB.
- WFD-103380* Performance issue: Schedule - Employment Terms search field was taking too long to become Active.

Timekeeping

- [WFD-106203](#) When attempting to access employees, the employees were not appearing in the manager's employee group. When reviewing the employee's primary job, it would show in the summary, but the history was blank.
- [WFD-103342](#) Totalization in the Background Processor (BGP) was stuck.
- [WFD-99597](#) Background Processor (BGP) was stuck.

UDM

- [WFD-107797](#) The following issue was occurring on all DX devices with employees assigned to Attestation Toolkit (ATK) profiles.
All employees, when punching out, are asked if they approve their timeclock punches and that they are accurate. If they answer "approved," the system should add a comment to their punch; however, this was not happening. The DX would accept the approval, but no comment was added in the timecard. However when they "declined", a comment was correctly added.

R7 Update 2, Express Upgrade 1

The issues below were resolved for the R7 Update 2, EU 1.

Scheduling

- [WFD-107669](#) On a node, high CPU usage or *Out.of.Memory* error occurred due to a large number of "OrgObjectRef"s being created.
- [WFD-107274](#) Slowness occurred when loading Schedule Planner.

Timekeeping

- [WFD-107378](#) The Timecard Metrics Multiread API was rounding differently in R7 Update 1 than it had in previous releases.
- [WFD-104015](#) The Attestation Toolkit (ATK) Qualifier for "working less than 3 hours" was prompting when working more than 3 hours.

R7 Update 2

The issues below were resolved for R7 Update 2.

Attendance

WFD-102522 The publish history listed success for all items. However, on the target tenant, the attendance actions did not reflect the correct configuration. Specifically, the "Auto Forward Documents", "Subject" and "Message" fields were blank or unchecked to match the source configuration.

WFD-102272 Edits on existing Attendance Policies did not save correctly.

WFD-100649 When adding a comment to an Attendance Event for Exception and Comment, the configured comment type could not be selected unless the comment was also assigned to the punches comment category.

Common Business

WFD-103382 When the tenant time zone was later than the user's time zone (example: Tenant = UTC, User = Eastern or Tenant = Central, User = Pacific) and users attempted to add a new badge number, the badge assignment start time defaulted to the current time in the user's time zone. When the user attempts to save, the following error appeared:

"1) Start time cannot occur before current time."

(This issue was first resolved for UKG Dimensions R7.)

WFD-103247 The HCM Payroll Export-v2 integration did not export records for terminated employees even though these employees worked during the pay period. Now, the integration fetches all employees in the Hyperfind for the exported date range or symbolic period and filters the records based on the input requests.

WFD-101912 When selecting the edit button in the **Employee Role > Employee Job Transfer Set**, the screen was unresponsive for a long time (for example, for more than 10 seconds).

(This issue was first resolved for UKG Dimensions R7.)

WFD-101400 When employees press the Punch soft key from the InTouch terminal, it invoked a Attestation Punch flow.

When an employee input their 10 digit badge number, the display said "waiting for server", and then an "Invalid Badge Number" error, followed by the employee name, and the date/ and time of the punch attempt.

(This issue was first resolved for UKG Dimensions R7.)

WFD-11317 The application's inactivity timer was being triggered prior to its configured expiration time, causing frequent "Session Timeout" windows.

Common Components

WFD-104138 An UltiPro People Import integration could fail because of an error in accessing the root node of the business structure.

WFD-102574 Business Structures were not shown in the user interface (in **Application Setup > Business Structure Setup > Jobs and Business Structure**) despite that the data existed.

(This issue was first resolved for UKG Dimensions R7.)

WFD-102427 The `CONSOLIDATE_ACTUAL_VOLUME` process failed multiple times with a `NullPointerException` with no additional information provided regarding their cause.

WFD-101359 The "Initialize Device with Device Download Options" and "Update Device with Device Download Options" actions that were initiated through Event Manager, were failing with the following error:

"Unable to communicate with customer's host system." Because of this, the customer's Intouch 9100 clocks were unable to download updates.

WFD-100584 In the **Timekeeping > Employee Role** section of People Information and in **Application Setup > Business Structure Setup > Organizational Sets**, performance was slow.

Configuration App

WFD-102103 SDM was recently changed to disallow configuration rules whose names begin with the special characters `=`, `+`, `-`, and `@` from being imported to tenants. For this reason, the application's user interface will now prevent rules and building blocks from being created with such names.

WFD-101870 The Publish button in Setup Data Manager (SDM) was non-responsive when a user attempted to initiate a file export from one tenant to another. This problem was addressed by adding file size validation in SDM and logging an error when the file exceeds the maximum size.

Forecasting

- WFD-105249** The Operational Dashboard in Forecasting was missing expected data and the following message appeared:
"The following metrics have been disabled and cannot be displayed: ,,,,...Contact your system administrator to enable them."
- WFD-104589** Forecasting events of `ADJUSTMENT_DRIVER` were coming with very big date ranges (01-01-1900 to 01-01-3000) in `kpi_domain_events` table. Only the impacted dates (which have any change in data) should be part of the event in the `kpi_domain_events` table.

(This issue was first resolved for UKG Dimensions R7.)
- WFD-104224** The machine learning Forecast for Thanksgiving week was not matching expectations. The forecast was below both the prior year and the trend for the current year.

(This issue was first resolved for UKG Dimensions R7.)
- WFD-104198** Several APIs that are used by the Field to migrate labor budget forecasting data to Data Hub were generating a "java.lang.NullPointerException" error when they encountered invalid data. More specific information about the invalid data was needed.
- WFD-104127** A user who assigned the French Canada locale could not assign hours of operation from **Administration > Configuration de l'application > Configuration Commune > Heures d'ouvertures > Affecter des heures d'ouvertures**.
- WFD-103577** When users ran the Forecast Volume engine from Forecast Planner and examined the engine status, the timestamp shown in the status did not reflect the user's time zone.
- WFD-102367** When the Labor Forecast Limit to which a job had been assigned was changed in **Administration > Application Setup > Forecast Setup > Labor Forecast Limits**, the job remained assigned to the previous Labor Forecast Limit.
- WFD-102091** After a change in the business structure, users could no longer view forecast data for the weeks before the change.
- WFD-101795** The Hour of Operation Assignment template is imported using the `/v1/commons/hours_operation/multi_update` API with Boomi. When the Hours of Operation Assignment import was run, the template did not appear in the application.
- WFD-101794** When the Closed check box in the Hours of Operation Override Template was selected, and the

template was assigned to a given day, no labor should have been generated for the day. However, labor was being generated for the entire day.

WFD-100873 The CONSOLIDATE_LABOR_BUDGET batch job failed repeatedly with the following error:

"WFP-01296 Invalid value S for command line switch."

WFD-103274 The Dataview Restore function did not work when personalized Dataviews were viewed in Pagination mode.

WFD-102788 When users exported the contents of a Dataview to a spreadsheet, it did not contain the six header records as expected. This caused all of the rows in the report to move up by one position resulting in a failure of the external system that consumes the data.

WFD-102766 The data values for some of the columns in a Dataview were displayed in English instead of in French as expected.

WFD-101849 Even when a Dataview download is only partially completed, a download file was created. Because users received no error message, they were unaware that data in the downloaded file was incomplete. As a result, users were misled into believing that all data was present in the download file.

Information Access

WFD-100684 For "Work" Dataviews, pagination behavior will now be triggered at 200 employees instead of 3500 employees as it had been previously.

"Work" Dataviews are Dataviews that containing any columns from "Work" entity.

WFD-99605 When downloading a Dataview, the following error appeared:

"Page not found. The requested URL was not found on this server."

WFD-11628 Attempts to download a Dataview that contains a substantial amount of data were repeatedly failing with a java.lang.OutOfMemory error that brought down the server node that was processing the download.

WFD-11403 When opening a Dataview that summarized Locations, if the default Location selection was returning more than 300 locations, an error message reported that the data for several columns could not be found. This error message did not provide enough information for the user.

Integration Hub

- [WFD-160286](#) The Retrieve Persons (POST /v1/commons/persons/extensions/multi_read) API operation did not return home cost center information along with primary job and labor category information. This operation has been enhanced to include cost center information.
- [WFD-104427](#) The Punch Export integration failed because of delays in API response.
- [WFD-104230](#) Users could not delete unused SFTP connections from integrations because the values were not cleared from the database.
- [WFD-104215](#) People Import integrations failed because of a time-out error. Retry handling resolved this issue.
- [WFD-103956](#) Integrations failed because GET and multi-read APIs were set to read-only and could not do insert or update operations.
- [WFD-101432](#) Integration runs showed multiple Transaction Assistant errors, and you could not distinguish real from false errors. Changes to log levels now prevent unnecessary error messages.
- [WFD-101197](#) The Transaction Assistant showed a validation error for integration runs when effective and expiration dates were the same, or the effective date was not defined.
- [WFD-100474](#) The TeleStaff Schedule Batch Import integration did not run even though the status was In Progress. The integration now updates the schedules correctly.

Leave

- [WFD-102940](#) When Leave of Absence requests on the Control Center page the options to take action on the request were disabled.
- [WFD-102663](#) When creating a leave profile and selecting leave type options, the leave profile would not save.
- [WFD-101973](#) When importing a Leave Document Template larger than 1MB, the import failed.
- [WFD-101783](#) When a Date based Leave notification is sent and the Leave Notification Note custom tag is included in the notification the Leave Notification Note custom tag does not populate.

Platform

- [WFD-104682](#) Production Monitoring routines run by Engineering flagged certain Hyperfind queries, running

across multiple clusters, that performed sub-optimally.

WFD-104554 When users selected a .gif file as the wallpaper image for the application homepage (using **Administration > Application Setup > Common Setup > Branding**), the file failed to upload and the following message was returned:

"Invalid file type selected. Choose another file".
.gif files are documented as a supported file type.

WFD-103859 When a user logged into the application with the Swedish locale and opened requests from Control Center, an incorrect date was listed as the Modified Date.

WFD-103854 Running the Employee Transaction Details report with an end date of 12/30/20 or 12/31/20 resulted in the year of the end date changing to 2021.

WFD-103817 When users logged into the application with the Belgian locale, and clicked the icon on an application page to access online help, the help slider panel that opened had no content.

WFD-103776 The `updateWfpUserTokenExpiration` procedure appeared to be blocking access to `java.util.Hashtable data`.

WFD-103277 When stating a delegation, managers received the following error even though their Function Access Profile access to Common API Beans was set to "Allowed":

"Error This task has failed runtime validation and cannot be completed when starting a delegation."

WFD-103167 If a Case note added to a Leave case contained any carriage returns, the note could not be saved.

WFD-103051 When a manager selected a Hyperfind in a Dataview, it did not show all the expected data. However, when a Super User chose the same Hyperfind, all the data was displayed.

WFD-103044 When a manager's Function Access Profile was set to "Only Self" in **Manager - Common Setup > Event Manager > Individual Events**, the Error WFP-113554 displayed when the manager used Event Manager

WFD-103019 Even though the password Expiration Frequency setting was set in their Logon Profiles, employees were not receiving the "password has expired" message on the expected day. This could result in a breach of internal security policies regarding password changes.

- WFD-102671* The status of batch jobs (Start Date and Time and End Date and Time in particular) was not being updated in a timely manner in the Batch Job List user interface.
- WFD-102616* An on-heap memory lock in the caching subsystem was causing high CPU usage on production tenants, for requests to `scheduling/v1/widget/employee/selfservice/contentSummary`.
- WFD-102577* The `CacheNotificationProcessingThread` code was causing high CPU usage on production tenants.
- WFD-102553* When a user attempted to edit the recurrence of scheduled report in the Reporting Jobs page, the start and end dates in the editing detail panel automatically switched from the locale-defined format (DD/MM/YYYY) to US-locale format (MM/DD/YYYY).
- WFD-102495* After using SDM to move a report that included a customized logo, the moved report displayed the UKG logo instead of the expected, customized one.
- WFD-102406* After a manager delegated another manager to take over the manager's responsibilities and the delegated manager accepted the delegation, the delegated manager was unable to perform the delegated tasks due to a time zone issue.
- WFD-102390* Users were not able to run a report in interactive mode from a mobile device. This is now working as designed and the "Interactive" label on the Run Report page or panel has now been changed to "Interactive (Desktop Only)".
- WFD-102284* Payroll Export integrations failed when the default Hyperfind was selected.
- WFD-102278* When users added a translation string for the Scheduling domain in **Application Setup > System Configuration > Translation > User Interface** and exported the translation to Excel, the string was not present.
- WFD-102267* When users created a scheduled batch event and selected **Run Now** to execute it immediately, there was no indication (either "waiting" or "running") that the request was being processed.
- WFD-102087* System Administrators were able to delete system-generated Hyperfinds by navigating to **Administration > Application Setup > Common Setup > Hyperfinds**, selecting one of the system-generated Hyperfinds (for example, "All People"), and clicking **Delete**.
- WFD-102050* Scheduled integrations ran before the scheduled date and time after the change to Daylight Saving Time (DST).

WFD-101872 When attempting to run a report that exceeded the threshold limit, the following error displayed:

***Notice Error: Error WFP-114323 Selected request are more than threshold limit. Please narrow your request criteria. ***

Because this error did not provide sufficient information, the error message now includes the following:

"Number of locations passed in request is above the threshold limit of 10000".

WFD-101864 The status of a batch job, such as `CONSOLIDATE_ACTUAL_VOLUME`, differed between that shown in the **Application Setup > System Configuration > Batch Job List** user interface and batchjob table - 3 (Retry), and that shown in the `batchjobtask` and `batchjobtaskitm` tables - 1 (Success).

WFD-101861 When users attempted to create a mapping category definition in KPI Builder, the following error appeared:

"Error HTTP-413 Request payload is too big".

WFD-101840 Connection failures across all tenants in a production environment (that were reported with the message "Too many open files") warranted that the `worker_rlimit_nofile` setting for pull requests on the tenants be increased from 4096 to 8192.

WFD-101684 For a manager using the French locale, the "Décliné" filter status for tasks in Control Center was obscured in the user interface and unreadable.

WFD-101675 When using UKG Dimensions, users received a Connection Lost error and had to restart the session.

WFD-101581 Due to an internal entity mismatch between TMS and OpenAM, authentication failed when attempting to log on to a tenant. The following error was generated:

"Authentication failed to Update and Activate. Status Code AUTHN-000120 Update And Activate failed."

WFD-101515 The translation of the Attendance tile did not use Canadian French, rendering an incorrect translation for the user.

WFD-101287 The People Import integration failed when importing records for newly hired employees.

WFD-101275 A manager was unable to delegate to another manager who has Spanish characters in their name, such as ñ, ó or M^ª. The Delegation failed with the following error:

"Error This task has failed runtime validation and cannot be completed. Contact your system administrator."

WFD-101061 The Batch Jobs list now shows jobs in the same default time zone of the tenant rather than in the UTC time zone. This removes the need to convert between time zones.

WFD-100955 The size of shared buffers and read-ahead buffers in the Postgres Plus Advanced Server database have been changed to 32GB and 16KB respectively.

WFD-100887 When running a report in the mobile application on both Android and IOS, the time frame selector drop-down arrow was unresponsive.

WFD-11504 When viewing an employee's timecard with the Polish language, the following terms were translated incorrectly:

- Accruals (Rozliczenia międzyokresowe)
- In (W)
- Out (Poza)

WFD-11378 Add Punch in Dataviews included undefined characters in the Japanese locale.

WFD-9514 Users were unable to delete location reference columns only from business structure report data objects (RDOs).

Scheduling

WFD-104980 OutOfMemoryError alerts occurred when a user was importing employee schedule patterns using the `/v1/scheduling/employee_schedule_patterns/apply_create` API.

WFD-104773 On the Daily Coverage tab in the Schedule Planner, data was very slow to load when there were multiple 1-hour time spans.

WFD-104769 When a manager added a Paycode for an employee in the Schedule Planner to zero out the employee's vacation balance, an error appeared stating that the edit could not be made because the balance was being overdrawn, even though the Paycode was added to the employee's Timecard with no error.

- WFD-104658** When managers attempted to apply changes to a Schedule Pattern for a Schedule Group, the following error appeared in Schedule Planner:
- "Error: Some Unknown Error Occurred".
- WFD-104571** Users were unable to log into UKG Dimensions due to performance issues.
- WFD-104543** When a Paycode was added using Quick Actions and a Warning displayed that there was a negative balance, there was no option to continue with the process even though overdrafts were allowed.
- WFD-104339** When open shifts were assigned by the Schedule Generator, Skills and Certifications that had been attached to those open shifts were removed.
- WFD-104223** When employees were in their Calendars to self schedule, the days on which they were already scheduled were showing two shifts in the Request Self-Schedule panel although only one existed.
- WFD-104128** When the `/v1/scheduling/standard_shift_sets/multi_update` API was used to remove a shift span from a standard shift set, the user interface did not reflect the change.
- WFD-103981** When shift times were added manually by using the Tab key to navigate in the Schedule Planner, the following error appeared even though the full proper shift time had been entered:
- "Invalid time of shift template name: x".
- WFD-103968** When a manager was logged in with a locale using a language other than English, the Approve and Refuse buttons in the Control Center were enabled, even though the requests had already been approved.
- WFD-103874** The Manager Tiles on all managers appeared to be causing high database connections, causing the user to max out its database connections and lose the ability to function properly.
- WFD-103549** A "504 Gateway Timeout" error was encountered during the execution of the PTI Integration process due to a response failure from the Create Employment Term Schedule Pattern (Shift) API.
- WFD-103523** The `/v1/scheduling/schedule/pay_code_edits/import` API did not return full details of each pay code edit and resulting shift changes.

- WFD-103317* When a date range was selected on the Indicators tab in the Schedule Planner, the scheduled hours incorrectly included hours from employees that had a job transfer in place to work at a different location.
- WFD-103311* When an employee tried to perform a Request to Cover or when a manager tried to use the Call List, the following error appeared:
- "Error: Some Unknown Error Occurred. Error Details Not Available."
- This occurred when the application attempted to use a Procedure Set to find the employees that can cover the shift.
- WFD-103300* When users attempted to enter a zero hour Time-off Request (TOR):
- "The following consistency validation failed: periods[0].startTime must be provided; periods [0].duration must be provided."
- WFD-103219* A manager received the following error message while approving a Time-off Request (TOR):
- "Error: You are trying to update an element that is being edited by another user or process. Repeat the loading process and try again".
- WFD-103166* Workload Planner was experiencing Out of Memory errors when incorrect Start and End dates were entered.
- WFD-103148* Employee visibility periods kept dropping off even though they were still open. This issue caused employees to see "No open request periods" in ESS and prevented them from self-scheduling and requesting time off.
- WFD-103142* The Schedule Generator did not correctly create open shifts as expected based on the assigned shift templates profile in the Schedule Generation Strategy configuration.
- WFD-103081* In **Application Setup > Employee Self Services > Pay Code Values Profile**, when changes were made to a field on one of the pages in the Pay Code Values Profile Editor, the configuration settings on the other pages were deleted.
- WFD-103032* After a manager approved an availability request, the notification in the detailed area correctly showed the Request Status as Approved but the actual notification still listed the Request Status as Submitted.

- WFD-103018** After setting parameters on the Add Volume page for the Workload Planner, the following error appeared when users clicked Apply:
- "Internal Server Error. Something went wrong while processing your request on the server. Please wait a moment and try your request again. If the problem persists, please contact your System Administrator".
- WFD-102995** The Schedule Generator was not correctly generating shifts that crossed the day divide even though employees had schedule tags that allowed their shifts to be extended.
- WFD-102941** Employee Time-off Requests (TORs) for a half day resulted in the system incorrectly adding a pay code for 12 hours instead of 4 hours.
- WFD-102893** When managers were manually entering time-off requests for employees in the Schedule Planner, dates for 2021 were not displayed in the calendar selection.
- WFD-102821** The Schedule Generator failed while generating schedules where all the selected locations were not assigned the same shift set.
- WFD-102781** When the Schedule Generation was run with the strategy to remove open shifts, the process took ten minutes to complete when it should have been completed in less than a minute.
- WFD-102775** Open shifts that were created by the Schedule Generator did not display in the correct sort order in the Schedule Planner.
- WFD-102739** When users attempted to import a Staffing Matrix using the Setup Data Manager, the following error appeared:
- "WFP-01298 An unexpected non-SQL system error has occurred. Please contact your system administrator".
- WFD-102651** Users were unable to update Scheduler fields in the People Editor. Attempts to save did not work.
- WFD-102569** When using the Replace Shift functionality for multiple employees in the Schedule Planner, the following error appeared if any of the selected employees did not meet the criteria, and the user was not able to proceed with the employees who could be updated:
- "Cannot find a shift to replace for x employees" occurred

- WFD-102566* When logged in using French, the Subject and Body sections in **Control Center > My Requests > More Details** were not translated into French.
- WFD-102524* Employees were not being sorted in the correct order in the Call List when the selected procedure set was configured to sort employees in ascending order by their Total Schedule Hours.
- WFD-102517* When attempting to add a labor category transfer to a schedule group in the Schedule Planner with Absence Calendar, the Labor Category Jobs list was blank.
- WFD-102513* The Staffing Dashboard was experiencing slow performance when it was being initially loaded and when dragging and dropping employees to other locations.
- WFD-102503* In the Schedule Planner, when scrolling through the list of employees when the All Home query was selected, the following error appeared:
- "Some Unknown Error Occurred. Error Details not Available".
- WFD-102498* The API to change Workload Setup was causing high CPU on BE nodes.
- WFD-102408* When a Schedule Pattern was edited and the availability segment was deleted on a day, another availability segment would display that had hours overlapping the deleted segment and was previously hidden.
- WFD-102404* When users ran a "Time Off Request" Dataview, the Submitted On Column displayed a different time zone than the time zone of the user who was viewing the Dataview.
- WFD-102271* When an employee tried to request a shift for self-scheduling, the following error appeared, even though the shift was available:
- "Error: Cannot find the shift 9025421".
- WFD-102268* The API to change Workload Setup was causing high CPU on BE nodes.
- WFD-102249* Adding a second day to a Time Off Request resulted in an incorrect span of time, which affected the appearance of scheduled hours and possibly affected the open shifts available to fill.
- WFD-102094* Some users were experiencing failed SBPF tasks that needed to be re-batched and re-submitted to correct stale data and avoid inaccurate payroll.

- WFD-102093* When a manager attempted to build a future-dated new hire employee's schedule with Shifts that contained Labor Category transfers, they received the following message instead of being shown Labor Categories that they could add as transfers:
- "Error: No primary job was found. Person xxxx."
- WFD-101989* Thousands of `SBP_CONFIGURATION` batch jobs were being created, but only one was running on each background processor at any given time. As a result, when users attempted to look at the schedule for a store, the application reported that it was unavailable due to an update.
- WFD-101987* When work rules were updated for a store and the change was set to start on a future date, the system applied the change to all schedules for all stores, which caused all the schedules to be locked while the background processing jobs were in progress.
- WFD-101974* After adding a schedule tag to an employee's schedule, when a manager attempted to add another tag to the schedule on the following day, the previous day's schedule was opened. When the manager saves it, that day's schedule was saved to the following day.
- WFD-101846* When the Employment Terms drop-down was selected in the Target Hours tab in the Schedule, the word "All" displayed in English instead of being translated to French.
- WFD-101835* A "504 Gateway Timeout" was encountered during the execution of the PTI Integration process due to a response failure from the Create Employment Term Schedule Pattern (Shift) API.
- WFD-101788* The Location Schedule - Weekly report and the Employee Schedule -Weekly report were incorrectly only displaying days that had schedule items, instead of showing all seven days of the week.
- WFD-101786* When attempting to edit a batch item in **Application > Setup > Common Setup > Batch Processing**, the page was taking more than a minute to load.
- WFD-101785* When attempting to recalculate a large volume of schedule items, instead of supporting partial success, a single error caused the entire transaction to fail.
- WFD-101767* The Dataview Time Off Request column (Incoming Request Count) showed an incorrect count for some employees, depending on the time period in both the Dataview and Schedule Planner.
- WFD-101674* Following an upgrade to R7, the following error displayed in a specific environment when users attempted to access **Application Setup > Schedule Setup > Schedule Rule Sets**:

"The HTML Framework has detected an exception in the application that you are attempting to access. The exception has not been caught; the application has failed to load. Please contact your administrator."

- WFD-101621** Multiple calls to the `/v1/scheduling/widget/daily_coverage/table_data` API from the same session were causing high CPU on a production tenant.
- WFD-101573** Performance issues due to high CPU on BCK nodes on a WFM were reported.
- WFD-101572** A rule violation indicated that an employee had not had enough required days off per schedule rule definition even though a schedule rule override was in place for minimum consecutive days off per validation period.
- WFD-101524** Shifts and breaks within shifts could not be moved or resized in the Employee View of the Schedule.
- WFD-101489** Time-off Request (TOR) notifications for all employees were not working when using Approval Settings. Employees and managers did not see the request in their Control Center or receive the submission or pending emails.
- WFD-101434** When an employee requested time off for a 1st or 2nd half day, the time off was not deducted correctly.
- WFD-101424** When adding a business structure transfer while adding a schedule tag to a day in the Schedule, an error displayed that the date format was incorrect and no data was displayed.
- WFD-101420** When creating a new Transfer Display Profile in **Application Setup > Business Structure > Setup > Transfer Display Profiles**, duplicate entries were displayed in the Business Structure Type list.
- WFD-101389** An employee's current shift shown in the Schedule did not match the Shift and Location shown in the latest entry in the schedule audits on the Audit tab.
- WFD-101366** When an edit is made with symbolic source of Full Contract Day, the amount is based on the schedule in the employment terms (the contract schedule). When this contract schedule is changed, the pay code amount is supposed to change to stay in line with the new contract schedule.

Although this was the case when the edit was made for a standard hours type Paycode or a duration type Paycode, it was not when the edit was made for a day type Paycode.

- WFD-101273* After a manager made a change to a shift in a Visibility Period, the period was closed and the employee could no longer self-schedule for that period.
- WFD-101153* When reviewing an employee's audit tab in Schedule Planner or calling the Retrieve Schedule Audits (POST /v1/scheduling/audits/multi_read) API operation, a "work rule not found" error could be incorrectly returned instead of valid audit data. The system now gracefully handles audit queries that include deleted work rules.
- WFD-101026* When an employee requested time off for a 1st or 2nd half day, the time off deduction was not included.
- WFD-100934* Accrual data was not being displayed in the Accruals tab of the timecard for certain employees, even though they were properly assigned to employment terms with accrual profiles.
- WFD-100913* When attempting to select locations in the Staffing Dashboard, the locations were taking a long time to display and sometimes the following error appeared:
- "Unknown error: Contact your system administrator".
- WFD-100790* When a user added a comment from the control center to a time off request, the user could add a note for the comment without first Selecting a Comment from the drop-down menu.
- WFD-100461* Managers were not able to enter time-off for themselves in the Schedule Planner due to the following error:
- "Request processing not allowed for this employee".
- WFD-100354* A Hyperfind query for the second level of a business structure returned no employees, whereas one for the first and third levels retrieved employees as expected.
- WFD-100112* When users attempted to add a new temporary employee while logged in under their agency account, the following error appeared:
- "WFP-00148 the specific primary job is invalid-Key: <key> Date <date>. The user does not have assignment access to the job on that date".
- WFD-99929* An employee who was assigned a standard pay code paid by the Combined Pay Code was incorrectly included in the list of eligible employees in the Call List when the procedure set had a rule assigned that excluded employees that had the pay code.

WFD-99783 When an employee's Schedule Rule assignment was changed, and if it contradicted a Schedule Rule override, the Schedule Generator failed due to the conflict when it was run for the employee's location.

WFD-11433 After an employee's primary job changed, currently scheduled shifts did not move to the new job location if the shifts were created with a break assignment.

WFD-11300 When employees ran the Request Time Off Smart View on a time clock, they sometimes received the following message:

"Rejected -An unexpected error occurred. Contact your system administrator".

WFD-11235 Schedule tags that were assigned to shift templates were not displaying for open shifts after the Schedule Generator was run.

WFD-11035 When users selected a Time-off Request (TOR), the start and end time translations were incorrect.

WFD-10992 The Create Paycode Edits (POST /v1/scheduling/schedule/pay_code_edits/multi_create) API operation did not correctly mark days as unavailable when using an appropriate paycode, such as "Time Off Unavailable." The operation now correctly marks such days as unavailable.

WFD-10922 Data on the Daily Coverage tab in the Schedule Planner was taking much longer to load than expected when there was only one job selected with a 1-hour interval for a 4-week time period.

WFD-10154 When the location of a store was moved in the Business Structure, the user had to manually update any batch tasks for the Schedule Generation Engine that referenced the previous path to the store. With this fix, the system now successfully runs these batch tasks when a store is moved in the Business Structure without the user having to manually update them.

SMS Shift Fill

WFD-104102 When creating a new open shift request, incorrect primary locations were being displayed for eligible employees found by the procedure set.

This issue was resolved for SMS Shift Fill patch 1.6.2.

WFD-103168 When creating a new open shift request, after selecting an open shift that spanned the day divide and then selecting a procedure set to use for finding employees, no eligible employees were

displayed and the following error message occurred: "Error occurred while trying to retrieve eligible employee list".

This issue was resolved for SMS Shift Fill patch 1.6.2.

Timekeeping

- WFD-105069** When a work rule was updated using the `/v1/timekeeping/setup/full_work_rules/multi_update` API, the majorities assignment was not updated for some work rules.
- WFD-104761** When using the `/v1/timekeeping/timecard_metrics/multi_read` API, some large paycode edits were not returned for the given date range.
- WFD-104541** Users were not able to transfer accrual policies from UAT to Prod with SDM.
- WFD-104149** In the timecard, when attempting to approve overtime segments that did not overlap the following error was received:
- "ERROR: The request contains 'overtimeApprovals' that overlap with existing overtime Approvals".
- WFD-104103** In a project timecard, after adding a comment for manually entered hours and then adding a comment for scheduled hours on another day, after saving the following error appeared:
- "Some Unknown Error Occurred. Error Details Not Available".
- WFD-104062** In People Information, when entering Employee Hours for Full-Time Equivalency, if the value was between 0 and 1 the following error was received:
- "(1) Zero value not allowed".
- WFD-103993** The Timecard Metrics API did not return Labor Category Entries in the "entries" array.
- WFD-103702** After opening **Time > Employee Summary** from the main menu and then selecting a Hyperfind, totals did not display for the first employee (even though this employee had totals).
- WFD-103570** In the timecard, when the symbolic source was Full Contract Day, the bonus rule in the employee's default work rule was not triggered.

- WFD-103567** On the timecard Audit tab, the effective dates for Sign-off removal did not reflect the correct date.
- WFD-103563** When a manager ran the FTPT Report for a specific employee and then ran the FTPT report using an ad hoc Hyperfind that included the same employee, the total hours did not match.
- WFD-103404** After adding a new labor category, employees were not being totalized and timecards were inaccessible.
- WFD-103373** When using the `timekeeping/data/import` API and submitting a request that had only partial success, the status code that was received (status code 400) made it appear that the entire request had failed.
- WFD-103316** When a manager attempted to delete a moved time amount in their own timecard, the following error was received:
- “Access right violation: you are not allowed to access this employee.”
- WFD-103286** For a time period that contained 2 holidays (Thanksgiving and the day after), the timecard reflected the correct holiday credits but the Dataview only showed hours for 1 of the holidays (for a total of 8 instead of 16 hours).
- WFD-102918** The hours total in the Employee Totals for Payroll report did not match the total hours entered in the timecard for the same time period.
- WFD-102894** For an employee configured to earn overtime after 8 hours, after adding 10 hours to a historical timeframe, 8 hours were added as Regular hours and 2 hours were added as Unapproved Time (even though the global setting for “Automatically approve unapproved overtime during Add Historical” was set to true).
- WFD-102786** When attempting to edit the name of a Scheduled Event from Event Manager, upon save an error appeared.
- WFD-102772** Some Hyperfind queries ran slowly when using the condition “Immediate Payout Hours Worked Equal 0”.
- WFD-102694** When editing a percent allocation rule trigger, after changing the cost center, saving, and then reopening the rule, the cost center change was not saved.
- WFD-102650** Historical corrections showed a blank Location and Job blank in Totals tab for the current period if these have been end-dated

- WFD-102593* After managers removed timecard approval, the timecard background color still reflected approval even though the removal appeared in the Audit tab.
- WFD-102529* In the timecard, the first transfer column showed the correct Business Structure string and the job but the second transfer column did not show the job.
- WFD-102380* When a manager (Manager B) approved a timecard acting as another manager (Manager A), the timecard audits correctly showed that Manager B approved the timecard, but the Dataview incorrectly showed Manager A as the timecard approver.
- WFD-102289* For two specific employees, historical corrections appeared in the timecard and then were saved. Once the corrections were saved and the timecard reloaded, the corrections were generated again for the same day.
- WFD-102255* After an accrual reset, an employee's ending vested accrual balance total (as shown on the Accruals tab) for a Floating Holiday was incorrect.
- WFD-101984* For a particular employee, when adding a labor category transfer in their project timecard, existing transfers also changed with the addition of a prefix. When they refreshed the timecard, the existing transfers reverted to their original state.
- WFD-101976* When logged in with a French Canadian locale, the translation for the Tiles panel (accessed from the Home page gear icon) appeared incorrectly as "Mosaiques" when it should have been "Vignettes".
- WFD-101879* After an employee's timecard had been signed-off, managers were still able to approve overtime from the Overtime Group Approvals page without having Enable Edits turned on.
- WFD-101876* For an employee whose hire date occurred in the middle of a pay period, when attempting to sign-off their timecard from a group edit the following error message was received:
- "Cannot make changes prior to the hire date"
- Sign-off was successful from the timecard.
- WFD-101866* In the timecard, holidays that used the "Average wages" credit type for the holiday credit rule had an amount of 0 instead of the expected amount. The amount appeared correctly on the Totals tab.
- WFD-101854* After making historical edits to their timecard, employees were not able to save and received the

following error message:

“Error Some Unknown Error Occurred. Error Details Not Available.”

- WFD-101761** When running the FTPT report for a specific employee and running the FTPT report using an Ad Hoc Hyperfind which includes the same employee, the Total Hours do not match.
- WFD-101742** After a business structure update, some employees showed transfers to their primary job on their scheduled shifts in the Schedule Planner and in the timecard. The transfers could not be removed.
- WFD-101699** When a location on the business structure was moved, the time the change was reflected used UTC time instead of the tenant's default time zone.
- WFD-101676** The Accruals tab in the timecard was configured to show the Current, Opening, and Ending probationary balances, but when viewing the Accruals tab data did not appear in the columns even though the employee had probationary balances.
- WFD-101668** In certain situations, the Bulk Accrual Reset (POST /v1/timekeeping/accruals/resets) API operation would return a CT Call error message that did not correctly replace the 'Message' variable with detailed error information. CT Call error messaging is now generated correctly.
- WFD-101649** When an employee reviewed the My Accrual Tile, the accrual balance was displayed in decimal format (HH.mm) rather than in hour format (HH:mm).
- WFD-101633** When editing an employee timecard, the following error appeared:
- "Error: A System Error was encountered during CT Call".
- WFD-101541** Accrual Policies that had been migrated from UAT to PRD using SDM listed incorrect settings, for example, missing grants and added new limits.
- WFD-101518** For managers who were configured to retrieve more than 3500 employees when viewing timecards, when the manager accessed the **Time > Timecards** option from the main menu they received an error message that timecards could not be opened, but they were not able to select a different Hyperfind to reduce the number of employees.
- WFD-101188** The Create or Update Persons (POST /v1/commons/persons/multi_upsert) API operation did not have a parameter that allows a caller to unassign "Labor Category Profile - Manager Additions". The new parameter unassignMgrEmplLaborCategoryProfile was added to

enable this functionality.

- WFD-101167** The `/v1/commons/persons/extensions/multi_read` API request returned an incorrect date for `managerSignoffThruDate` (the date did not match the date in People Information), causing the integration to fail.
- WFD-101053** For an employee with a negative accrual balance, even though the negative balance was allowed, the employee's manager was not able to approve their timecard.
- WFD-101051** In the Exception Counts by Employee Dataview, data in the Unexcused Absence exception column did not update even though the manager had edited the employee's timecard and no exceptions appeared in the timecard.
- WFD-101042** After entering a historical edit Paycode and clicking Calculate Totals, the system automatically generated another Paycode in the timecard.
- WFD-101031** The Bulk Delete Paycode Edits (POST `/v1/timekeeping/pay_code_edits/multi_delete`) API operation incorrectly allowed edits to signed-off periods. Such edits are no longer allowed.
- WFD-100965** When users tried to open a Dataview and run reports, the following error appeared:
- "Internal Server Error: Something went wrong while processing your request on the server,. Please wait a moment and try your request again. If the problem persists, please contact your System Administrator."
- WFD-100787** An employee with a cascading accrual policy had an accrual balance of 148. When a taking of 84 was entered, only 74 hours were taken from the accrual balance and 10 hours were applied to unpaid time.
- WFD-100714** When editing paycodes or combined paycodes, changes for minor updates such as a name change took between 15-60 seconds.
- WFD-100309** After updating an accrual policy with a new effective date, duplicate copies of the accrual policy appeared in the available accrual policies list in the GDAP. This also caused the following error when using SDM for the GDAP:
- "WFP-01555 There are duplicate GDAP Items in the Request."
- WFD-100210** In the timecard, dates for historical corrections were using the UTC time zone instead of the

tenant's default time zone.

WFD-100198 When attempting to open the timecard with the Current Pay Period, the following error message appeared:

“Error Can't overwrite cause with
com.kronos.tk.timecard.widget.common.converter.ConverterException”.

WFD-100017 Changes to totals were still calculated even though a Payroll Lock had been applied.

WFD-100012 In the timecard, an employee's daily schedule for a Sunday to Monday shift (where the work belongs to Monday) was not visible when the selected timeframe was Next Pay Period.

WFD-99782 An accrual grant of 8 hours was configured for employees on their date of hire, but the grant was not awarded.

WFD-99580 When an attestation question was defined with the condition of 6-10 hours, the wrong question displayed when employees punched out for the end of a shift.

WFD-11575 An employee worked a shift on a holiday that was not their scheduled shift. The employee was not paid correctly for the holiday, even though their holiday credit rule defined scheduled shift eligibility as “Any shift on day of scheduled shift”.

WFD-11427 After editing an employee's schedule to add a duration Paycode for 1.5 hours, the employee's timecard reflected an early out exception even though exceptions were not configured in the employee's work rule.

WFD-11353 For a specific employee, the total for unapproved overtime hours in the timecard did not match the total listed in the Overtime Hours Dataview.

WFD-11336 In a Dataview, the total hours for an employee appeared correctly when using a symbolic timeframe, but appeared incorrectly when using the date range for the same time period.

WFD-10907 When attempting to update an employee's primary job in People Information, the following error message appeared (even though the entered effective dates did not have a gap in time):

“Error WFP-00924 Gaps of time between date ranges are not allowed - Expiration: 11/05/2018, Effective: 8/11/2019”.

WFD-10844 In People Information, when editing an employee's employment term and then terminating the

employee, the change to the employment term was not saved.

WFD-10350 After changing a Paycode in an employee's timecard, the Historical Corrections tab listed the old Paycode with an amount that was double the original amount.

WFD-10271 When request subtypes were configured to use a normal day pay code or a cascading day pay code, the results in the employees timecard were inconsistent.

WFD-9379 Accrual takings were not working as expected for cascading accrual policies when the balances in each level did not exactly match the taking amount.

UltiPro

WFD-103278 A Dataview was showing incorrect details for FAPs when there were Multiple Manager Roles.

Universal Device Manager

WFD-103564 When attempting to save an existing softkey setting to a 4500 profile, no softkeys appeared and any attempt to save with or without adding a softkey resulted in the following error:

"com.kronos.udm.platform.exception.DevMgrRuntimeException: Update failed. Data is stale, and has been modified by another user. Please refresh and try again."

WFD-103484 Attempting to initialize InTouch devices through Event Manager resulted in the following error:

"Error: The xml does not adhere to the Xml Schema Definition"

WFD-103020 When a new device group was created, users were unable to add devices to the group. Additionally, if the new device group was selected, no drop down list would appear after selecting Actions.

WFD-103006 Users were encountering the following error when attempting to navigate to the Device Profile or Devices page:

"Error: Cannot map entity. Document type "[UDM document name]".

WFD-102753 The device configuration "CAH InTouch Device - Device Initiated ATK" would not load in UDM. None of the options for each configuration profile were being displayed, and the number of

devices assigned showed "0" even when there were active devices are assigned.

WFD-102702 When employees used a Location Transfer softkey on any InTouch device with Default Location configured without the Prompt for Location selected, the punch was accepted and registered at the timecard but the Location Transfer was not included with the punch.

WFD-102615 Attempting to import configuration into an environment using SDM was resulting in multiple errors. Additionally, users were receiving an "unhandled exception" when trying to import application configuration changes into UDM.

WFD-102155 When attempting to save an Application Configuration setting after clicking Select Existing, a spinning wheel appeared for up to 10 minutes.

WFD-11161 Users were encountering the following error when clicking the custom Attestation Transfer softkey:

"WFP-101038:: This task has failed runtime validation and cannot be completed. Contact your System Administrator".

Work

WFD-103297 Users were able to retrieve information about the user who made activity edits and activity result edits using work audit IA entities used in data view.

Two new columns now appear in the IA data dictionary for the user name of employee who made the activity and activity result edits.

Entities:

- ACTIVITY_AUDIT
- ACTIVITY_RESULTS_AUDIT

Column keys:

- WORK_ACTIVITY_AUDIT_RAW_SEGMENT_USER_NAME
- WORK_ACTIVITY_AUDIT_RESULT_USER_NAME

WFD-102700 An integration was failing, which used the "Integration - Weekly Workday Payroll Export" Hyperfind.

(This issue was first resolved for UKG Dimensions R7.)

WFD-101442 Some service and support accounts did not have an Activity Profile assigned for tenants with Work entitlement. When using one of these profiles, any attempt to add an existing Activity to the timecard results in one of these errors:

- Attempting to select an Activity in the timecard resulted in the following error:
"Error WFA-212013 You do not have access to the following activity: (selected activity)"
- Attempting to select an Activity from the Manager Activity function results in the following error:
"Error WTK-200040 You do not have access to the following activity: (selected activity)"

WFD-100854 Users were unable to add an activity on the first or last day of the pay period.

(This issue was first resolved for UKG Dimensions R7.)

WFD-100757 Previously, there was no limit for the number of employees who could be assigned to a single activity. The maximum number of employees assigned to a single Activity can now be assigned using the "Direct Assignment" functionality in the Activity definition.

R7 Update 1, Express Upgrade 5

The issues below were resolved for the R7 Update 1, EU 5.

Forecasting

WFD-103578 Users were unable to move business structures from UAT to PRD using SDM, and the following error appeared: "*Some Internal Server Error Occurred. Please contact System Administrator.*"

Healthcare Analytics

WFD-102934 When running a specific Healthcare Analytics report (SixPayPeriodsProductivityTrend) for a WorkUnit of 900, it failed with a "*WFP-114011*" error. This report could be run successfully with less data selected.

Platform

WFD-108407 When users had workflow notifications configured (for example, four workflow notifications that

triggered on Mondays and Fridays with a total of 1,200 employees per notification), the notifications were no longer triggering as expected after a certain date, and were only sent intermittently.

WFD-105251 An Employee Pay Period based notification was being sent one week early instead of on the expected date.

WFD-102291 One employee whose primary job assignment was seemingly blank in the user interface (but which existed in the database) was causing the entire UDM Event downloading employee schedules to fail.

WFD-102050 Scheduled integrations ran before the scheduled date and time after the change to Daylight Saving Time (DST).

Scheduling

WFD-108497 An Employee Job Transfer set running very slowly and needed to be aborted.

WFD-107121 API calls to `v1/commons/peopleinfo/employee/role/getScheduleJobList` were causing high CPU usage and no response was being returned.

WFD-108011 When users submitted a Time-off Request (TOR) that spanned across two months, an incorrect number of days was displayed in the request dates.

WFD-105143 When end-dating a Schedule Group via Person Record, it was not saving correctly and the Forever end date was retained.

WFD-105140 When overriding availability in Schedule Planner, the following error appeared: "*The following availability records were not found: #####*".

WFD-103523 The `/v1/scheduling/schedule/pay_code_edits/import` API did not return full details of each pay code edit and resulting shift changes.

WFD-102652 `laborCategoryProfileService` was not returning a list of entries

WFD-102085 When attempting to perform a business structure transfer in Schedule Planner for one employee, a "*Page unresponsive*" message appeared.

Timekeeping

- [WFD-104203](#) High memory usage on three nodes, even after restarting.
- [WFD-102918](#) The hours total in the Employee Totals for Payroll report did not match the total hours entered in the timecard for the same time period.
- [WFD-11583](#) -A Hyperfind used in Integrations was failing with a "*Code 504: Gateway Time-out*" message.

R7 Update 1, Express Upgrade 4

The issues below were resolved for the R7 Update 1, EU 4.

Analytics

- [WFD-106475](#) There were negative hours in Employee Actuals report for a part-time employee. This issue was related to Paycodes. Now the Cost Only flag for Paycodes will be considered for EPT Calculations.

Forecasting

- [WFD-108180](#) Machine Learning was forecasting much higher results than expected. For example, it was much higher than the forecast using Daily Trend 6 week for the same location and for the sales from the same week the previous year.

Leave

- [WFD-103763](#) High CPU usage occurred on a node due to multiple calls to `v1/leave/leave_edits/multi_delete`.
- [WFD-101507](#) High CPU usage occurred on a node due to multiple calls to `v1/leave/leave_cases/grant`.

Platform

- [WFD-104554](#) An "Invalid file type selected" error appeared when updating background wallpaper with a .gif.

Scheduling

- WFD-108298** When users attempted to approve or submit Time-off Requests (TORS), they failed and an internal error appeared.
- WFD-108261** High CPU usage on a node was causing severe latency.
- WFD-106625** When employees were selecting shifts for Request Self-Schedule in ESS, there were random days missing which they could not select shifts for, even though open shifts existed.
- WFD-103766** Employees were unable to request Time-off as if there were no visibility periods configured for the employee. However, when logging in and reviewing the visibility periods, the employee was included in a period.
- WFD-102608** CPU usage occurred on a node due to multiple calls to `v1/widget/scheduling/v1/widget/manager/schedule/group/content`.
- WFD-102150** Generating the Location Schedule - Monthly report took a long time (for example, about 8 minutes) for a date range of 6 weeks at one location (about 600 employees).

Timekeeping

- WFD-106433** The following issues occurred:
- Unwanted historical corrections were generated on pay periods that were already signed off.
 - The historical corrections from the previous pay period were carried over to the pay period being processed by the payroll administrator.
 - The payroll administrator was unable to sign-off on timecards without enabling edits.
 - When enabling edits before signing off the timecard, the historical corrections were duplicated.

UDM

- WFD-107512** at a tenant refresh were stuck or failed at UDM while performing the cleanup action.
- WFD-107508** at a tenant refresh were stuck or failed at UDM.

R7 Update 1, Express Upgrade 3

The issues below were resolved for the R7 Update 1, EU 3.

Mobile App

WFD-101425 In certain situations, an employee configured for extended authentication was being required to log back in during the extended authentication period.

This has been resolved in the latest version of the Mobile App, 2.4.3. Now, if the app appears logged out when accessing it during the extended authentication period, simply go to the device's home screen; and then tap the app icon. When the app reappears, the logged in session will resume.

Integration Hub

WFD-101197 When triggering the Schedule Batch Import from WFTS, the event status showed as In Progress. However the IPack did not run in Boomi, and the schedule changes did not appear in the system.

Platform

WFD-105920 Workflow Notification were intermittently not working.

WFD-101963 When using the Chrome browser, if you hovered over the events in Event Manager, it was "off" a line; requiring to click the line above in order to select the event. This issue has also been seen in other areas of the application that have lists.

WFD-100949 In **People Information - Additional Information**, random duplicate entries were displayed.

WFD-11317 The system timed out while performing Work operations.

Scheduling

WFD-106628 In Self Scheduling, employee was unable to add or edit any shifts after the Manager updated a shift in Schedule Planner.

WFD-106421 When an employee attempted to select shifts to self schedule, the following error occurred:
"Error Invalid request type: SELF_SCHEDULE."

WFD-104010 Rest Rule Violation with "No Save" severity was not preventing the manager from saving change in the Schedule. The system should have stopped the user from making a change due to the *no save* severity.

WFD-100913 were receiving random popup errors when using Staffing Dashboard, such as Error Unknown error: contact your system administrator. Also, hyperfinds were slow to display locations and Unknown Error occasionally appeared.

Timekeeping

WFD-106341 was experiencing a high number of JDBC connections and thread blocking.

WFD-105741 The Person Upsert API removed Symbolic Reviewer assignments in **People Information > Manager Role-Assignments** even though this field was not included in the request body. The API should only update fields that are included in the request body.

WFD-106753 A dataview for Payroll-Employees with Exceptions was not producing correct results for the displayed employees. The dataview should match the timecards for exception totals.

WFD-104514 During the import of accrual reset transactions (with API v1/timekeeping/accruals/resets), the API calls were intermittently failing with the following error: *"An Error was encountered during CT Call with error message: Message."*

WFD-104335 Customer's pay rules were configured to enable edits 17 hours after the pay period ended. However, after the sign off completed for timecards, edits could immediately be performed on the timecards.

WFD-102267 If you created a scheduled batch event and attempt to run it now (instead of in the future) using the **Run Now** button, the button did not show any indication that the request was being processed.

WFD-101854 Issue with saving Historical Corrections. When they attempt to save after historical corrections were listed as pending for review, the following error message appeared: *"Error Some Unknown Error Occurred. Error Details Not Available"*.

R7 Update 1, Express Upgrade 2

The issues below were resolved for the R7 Update 1, EU 2.

Platform

[WFD-107244](#) When using the columns Manager Approval Status or Employee Approval Status in a dataview, the column was not populating with information when approval had been completed on the employee.

Scheduling

[WFD-105929](#) The schedule data patcher was failing.

[WFD-104643](#) The schedule data patcher was failing.

[WFD-104104](#) Employee was unable to self-schedule or view schedule in My Calendar. The following error appeared: *"You are trying to update an item that has been deleted by another user or process. Reload and try again."*

[WFD-104951](#) While scrolling through the schedule planner, the following error appeared: *"Error: Some Unknown Error Occurred. Error Details Not Available"*.

[WFD-103505](#) When a user was viewing the Schedule Planner "By Job" view, there were shifts showing that did not have an associated name. Attempts to edit the shift were met with the following error: *"Error Cannot read property 'id' of undefined"*.

[WFD-102925](#) NPE was occurring in production : FindRuleViolationsTask, GetColumnValuesTask, FindRuleViolationsColumnTask, FindTransferSetByEmployeesTask.

[WFD-101694](#) The schedule data patcher was failing.

[WFD-100635](#) When a manager performs an Enter Time Off via the schedule planner, the list of presented pay codes should only be from the Employees Pay Code Value Profile. In this case, the manager was presented with additional pay codes from the Managers Pay Code Value Profile and the Managers Pay Code Edit Profile.

[WFD-99135](#) When the primary job is updated, the schedule maintenance batch job will initiate the recalculation of effected schedule items. In this case, when the schedule items were recalculated in order to update the primary job with the latest employee's primary job, the personality API called by scheduling returned the employee's previous job value.

Timekeeping

[WFD-105092](#) An employee was generating duplicate historical corrections whenever edits were

enabled. Historical corrections should only be generated once.

WFD-102082 Dataview totals were not matching Timecard totals for prior signed off periods as well as current non-signed off period. All employees were up to date on totalization.

Universal Device Manager (UDM)

WFD-104950 Inconsistent behavior in the UDM dashboard filter. Differences occurred when selecting/deselecting a filter option either in the left panel or removing the filter selection from the results area.

WFD-101747 Performance issue: extreme slowness in the UDM module. General navigation of the UDM module was taking longer than expected and occasionally froze; the user needed to close the webpage. Also, actions like 'Test Device' and 'Initialize' were taking much longer than previously experienced.

R7 Update 1, Express Upgrade 1

The issues below were resolved for the R7 Update 1, EU 1.

Forecasting

WFD-103942 Tenant Cloning was failing on the Forecasting component.

(This issue was first resolved for UKG Dimensions R7.)

Key Performance Indicators

WFD-104531 KPI Event Processing was causing out.of.memory errors on Background Processor (BGP) and API nodes.

Platform

WFD-106447 The log was not showing the correct TenantID and User to assist with troubleshooting.

WFD-104860 Users were unable to edit or delete a Control Center Profile, and the following error appeared:

"Error WCO-104000 The control center profile could not be saved. Try again".

(This issue was also resolved for UKG Dimensions R7.)

Scheduling

WFD-105426 Managers were unable to approve time off requests after R7 Express Upgrade 11 for some employees.

(This issue was first resolved for UKG Dimensions R7.)

WFD-104229 When trying to edit a shift set, the following error appeared:

"WFP-00745 The string is too long for this value."

The maximum length is 30 and the edit content was exactly 30 characters, which should have been accepted.

(This issue was first resolved for UKG Dimensions R7.)

WFD-104004 Editing or updating an approved time-off Paycode in the Schedule Planner wasn't overriding the accrual warning value.

(This issue was first resolved for UKG Dimensions R7.)

WFD-103960 When accessing the 'Employee Role' in the People Information record of any employee (regardless of Function Access Profile), the following error appeared:

"Page Not Found The requested URL was not found on this server."

(This issue was first resolved for UKG Dimensions R7.)

WFD-103590 An error appeared in Schedule Planner when selecting a date for an employee in the future.

(This issue was also resolved for UKG Dimensions R7.)

WFD-102890 Performance issues occurred with Schedule Planner.

(This issue was first resolved for UKG Dimensions R7.)

WFD-102523 A patch was found to be returning false positive data.

If an employee was missing their record in the `schedule_employee_schedule_pattern` table, then a user could see the employee's shifts; but if they opened the pattern dialog for the employee, the assignment would not display.

If a user needed to make a change, their only option was to create a new assignment which would then result in duplicate schedules.

(This issue was first resolved for UKG Dimensions R7.)

WFD-102606 High CPU occurred on a tenant due to call to `v1/widget/employee/selfservice/content`.

WFD-101295 Following the resolution of an issue (the employee visibility period sent workflow notification for a single period or the first recurring period. It did not send notifications for subsequent recurring periods), users were receiving emails with **old** request periods.

WFD-100928 The Timecard API returned incorrect values for `orgJob` and `transferString` for second shift segment of system generated transfers.

Timekeeping

WFD-104741 Long running Hyperfinds occurred for the following GET request:

`v1/timekeeping/timecard/changes`.

(This issue was first resolved for UKG Dimensions R7.)

WFD-103398 Some Dataviews were not returning data for all pay periods, and the following error appeared:

"Data within columns cannot be retrieved. Contact your system administrator."

(This issue was also resolved for UKG Dimensions R7.)

WFD-103140 Employees were being dropped from the On Premise report shortly after the end of their shift, even though they were still on-premise.

WFD-102923 The `v1/timekeeping/timecard_metrics/multi_read` API was not returning nested combined Paycodes.

WFD-100485 The callable Totalizer was calculating an Incomplete Worked Span (missed punch present). This occurred when two spans linked to same shift and the completed span's In-Punch matched the Scheduled Start Time of shift after Sign-off.

(This issue was first resolved for UKG Dimensions R7.)

Universal Device Manager

WFD-105607/ After users refreshed a tenant, it became stuck and a UDM Internal Server Error appeared.

WFD-105757

R7 Update 1

The issues below were resolved for the R7 Update 1.

Attendance

WFD-101300 When an effective-dated attendance profile was created the profile did not apply correctly to attendance policies.

WFD-11429 The Update Attendance Profile for Multiple Employees (POST `/v1/commons/persons/attendance_profile/multi_update`) API operation incorrectly generated an error when the consumer attempted to assign an Empty Profile. The ability to assign an Empty Profile has been restored.

WFD-11063 Perfect Attendance Policies using scheduled day tracking periods did not give employees Perfect Attendance Credit when the employee had no disqualification for the credit.

WFD-10829 Managers did not receive an email notification when an employee submitted a time-off request.

Common Business

WFD-103220 Managers were no longer receiving notifications for Time-off Requests (TORs) via alerts from the bell icon.

(This issue was first resolved for UKG Dimensions R7, with WFD-101527.)

WFD-100943

Users were unable to end-date badge numbers as "None" in the People Editor. When selecting "None" in the dropdown, the following error appeared:

"Error: WFP-00913 The field value has detected a character that is not one of the allowed characters for this field. Field Name: Badge Number, Allow Set 0123456789 Value: <None>."

(This issue was first resolved for UKG Dimensions R7.)

WFD-100437 Managers were unable to save changes in People Information. When attempting to save, nothing happened. Their FAP was set to Allowed.

(This issue was first resolved for UKG Dimensions R7.)

WFD-11133 In People Information, when attempting to edit an employee job transfer set, after selecting the Edit button the following error message appeared:

"Select a set to edit."

WFD-11122 The `v1/commons/data/multi_read` API was failing for some employees, causing the following error:

"WCO-106017 Unable to resolve Employee-Qualifier for the specified request parameters: [employee numbers separated by commas]."

The employee numbers that cause this error are listed in the error message. Users needed to exclude these employees from the API request body to prevent the error from recurring.

(This issue first was resolved in a UKG Dimensions R7 update.)

WFD-11074 In certain circumstances, the Retrieve Persons (POST `/v1/commons/persons/extensions/multi_read`) API operation failed to correctly return valid, existing employees. The operation now correctly returns all valid employees.

WFD-10925 Managers were unable to change the Authentication Type for an employee in the People Information record because the Authentication Type field was disabled (grayed-out).

WFD-9559 After creating a new employee with a start date of today and the (GMT +12:00) Auckland; Wellington time zone, the account was not activated immediately so the employee could not login on their first day and the administrators could not view the employee in People Information.

Common Components

WFD-101043 After creating a future dated location on the Business Structure and then adding the location to a new Organizational Set (which had the same future date for its “As of Date”), the location was not saved unless users selected the day after the location’s start date.

WFD-11315 When navigating to **Administration > Application Setup > Business Structure Setup > Jobs and Business Structure**, the Business Structures did not appear.

WFD-11091 When attempting to change the name of a job on the Business Structure, an error appeared.

WFD-10276 When attempting to create an Organizational Set, the following error was received:

“Unknown error. Contact your system administrator.”

An error was also received when attempting to import the data using the API:

“WTK-02166 Another Org Map Group with the same name already exists”.

Configuration App

WFD-99934 While using SDM to import data from one tenant to another, users were unable to access the target tenant from the SDM list on the source due to an "HTTP status code 413 Payload Too Large" error. The tenant import process's default payload maximum size was increased to prevent this error.

WFD-99609 Setup Data Manager could not import system settings from the UAT environment to the PRD environment. The following error appeared:

"WFP-113002 Generic System Exception".

Database

WFD-99797 Managers were receiving various notifications to their mobile devices from more than one tenant. In certain situations a manager could not interpret the notification because of a lack of context.

Forecasting

WFD-100019 There were performance issues with Multi_Update for forecasting Integrations.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-99916 The volume forecast for the Transaction Register driver was significantly lower than expected when the Machine Learning forecast type was used.

WFD-99909 When the Update Values for Multiple Custom Drivers (POST `/v1/forecasting/custom_driver_values/multi_upsert`) API operation encountered an error while processing a record and generated an HTTP status code 400 or 207 Partial Success response, the error offsets were not specified in the response body. Error offsets are now included.

WFD-11611 When an administrator attempted to add a job to a duplicated labor forecast limit (**Application Setup > Forecaster Setup > Labor Forecast Limits**), the following message was displayed:

"Unknown exception: invalid org tree data".

WFD-11607 Because the sequence of jobs listed in batch tasks was not being followed, incorrect data was being generated in the volume and labor forecasts. Machine Learning Volume Forecast for Transaction Register was forecasting values that were much lower than expected.

WFD-11462 Background batch service jobs were stalled in a waiting state when processing earned hours on all nodes on a WFM.

WFD-11316 The api `/v1/forecasting/labor_forecast/apply_read` was failing with a null pointer exception. The following message appeared: "*Some Unknown Error Occurred. Error Details Not Available.*"

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-11287 When Batch Processing for the Labor Engine (and Earned Hours) was run at the organization level, there was no splitting over multiple automated batches (as is done for the Volume Forecast Engine and Labor Constraint Engine.) All the batches ran on the same thread; this should be handled by multiple threads.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-11201 When an administrator used the "As of Date" to make selections from the business structure in **Application Setup > Forecaster Setup > Labor Forecast Limits**, the locations that were returned were incorrect.

HCM

WFD-132147 When users performed the following steps, the system looped back (refreshed the existing screen):

1. Users navigated to **Recruitment > Candidates > Applicants**, then selected View Applicant.
The Application Information page appeared.
2. Users navigated to the Applications tab and selected the check box next to a Job application.
3. Users clicked on the ellipses and then the View Selected option.
The Job Application page appeared.
4. Users clicked on the application or browser "back" button.

Information Access

WFD-101373 When loading employee data in a Dataview in Pagination Mode (more than 1000 records), some columns were blank.

WFD-11449 When creating a chart in a Dataview, when multiple employees had the same name, the chart combined the totals for the individual employees into one employee name.

WFD-11337 The Casual Cost Hourly Rate column is configured to display values for Casual Workers only. However, the column was showing a value for full-time workers.

WFD-11189 Dataviews did not consistently return all applicable fields when both UKG Dimensions and HCM Fields were used.

WFD-10957 When Dataviews were exported with Spanish characters (such as á, é, í, ó, ú) the export format was UTF-8 instead of ISO-8859-1 (ANSI)

WFD-10756 In rare circumstances, the Submit Bulk Download (POST `/v1/commons/exports/async`) API operation could become stranded during execution of the asynchronous request and incorrectly respond with an HTTP status 413 error. The operation now handles these circumstances gracefully.

WFD-10678 A "KPITIMESERIESSYNCAEMON STALLED" error was occurring on Background Processor (BGP) servers.

(This issue was first resolved for UKG Dimensions R7.)

Integration Hub

WFD-100430 For failed integration runs, Message Details did not display multiple error messages on separate lines, but in a single mass of text. The multiple messages are now separated and easier to read.

WFD-11186 Scheduled integrations that have start dates from the 1st to the 12th of a month switched the month and day. Example: An integration scheduled for 12-10-2020 is intended to start on October 12, however the month and day would switch to December 10.

WFD-10711 Scheduled integrations for a location set that was updated did not run for all locations in the updated location set.

WFD-9049 People Imports of employee records with hire dates on the following day were not updated in People Information until 12:00 PM (noon, midday) New Zealand time (GMT+12). A change to the default time zone on the tenant shows newly hired employees in People Information at 12:01 AM on the hire date.

Key Performance Indicators

WFD-101639 The Custom Projected Hours custom KPI was not displaying in Dataviews as it was defined (scheduled hours remaining in the week, plus hours already punched).

WFD-100507 There were Dataview and metric discrepancies in a specific Dataview and in the timecard landing page. In particular, there were discrepancies in the Sch Hours and Act Hrs columns in the Dataview, and scheduled and projected hours on the timecard landing page.

(This issue was first resolved for UKG Dimensions R7.)

WFD-99866 Users were unable to run Historical Loads and an error appeared.

(This issue was first resolved for UKG Dimensions R7.)

WFD-11246 On many Dataviews, the following error appeared:

"Data within Actual Hours, Data Up-to-date, Non-Productive Hours and 7 more columns cannot be retrieved. Contact your system administrator."

(This issue was first resolved for UKG Dimensions R7.)

WFD-11089 The KPI status command (./kpi_app.sh) listed errors and erroneously reported that the KPI application was not running.

WFD-11023 The KPI application was repeatedly failing with a null pointer exception, which caused KPI events to not be computed. As a result, when users looked at KPIs in a Dataview, the latest data was not presented.

Leave

WFD-11597 When a leave administrator had to override some leave takings, an error appeared stating that the employee's vacation time is overdrawn.

WFD-11113 Users were unable to add leave time against a Leave of Absence case in the Leave Editor or on the timecard for specific employees.

WFD-11011 When navigating between the Leave Case Editor page and the timecard, the selected employee in the Leave Case Editor was not always displayed in the timecard.

WFD-10726 When a Leave of Absence rule was configured with the Scheduled Days trigger, the rule was not applied correctly.

Platform

WFD-100920 High CPU usage occurred on a production tenant.

WFD-100862 Delegation authority for managers was not working. A delegate was unable to open employee timecards, and a "Not Authorized" error appeared.

(This issue was first resolved for UKG Dimensions R7.)

WFD-100850 The log format was not working. This affected Support's ability to quickly identify performance issues for tenants.

WFD-100569 When the locale was set to Spanish (Spain) or Spanish (Mexico), the terms "Recurring Period" and "Rolling Period" in Employee Visibility Period had identical Spanish translations.

WFD-100487 When users attempted to log into the Microsoft Teams Chat Bot add-on, the following message appeared:

"Invalid credentials, please try again".

WFD-100285 When outputting a table in CSV output, the order of the columns was different than the order defined in **Administration > Application Setup > Common Setup > Published Reports > Edit Design > Data > Manage Parameters Output**.

WFD-100217 After an issue with blocked batch threads was resolved, the Batch Job List table still showed batch jobs in WAITING status.

WFD-99806 Performance of the Off Cycle Payroll Export integration was suboptimal.

WFD-11613 Although the All My Direct Reports Hyperfind query returned data when it was run by a manager, it did not return data when a manager was logged in as a delegate.

WFD-11518 When a specific date range was specified for a timecard or schedule, and a user selected the GoTo menu to link to the Reports screen and run the Time Detail report, the time period selected for the report did not match the previously selected date range. Rather, it defaulted to 'Today.'

WFD-11492 Payroll Export integrations failed because the Hyperfind query failed.

WFD-11475 Uncaught exceptions occurred, resulting in a fatal error on nginx nodes on many hosts.

(This issue was first resolved for UKG Dimensions R7.)

WFD-11473 Because batch jobs that have been running for over an hour were automatically being restarted, multiple versions of the same job would then be running at the same time. An adjustment in the default value of the site.BatchService.retryThresholdInMinutes system setting was requested to avoid this issue.

WFD-11278 The Create or Update Known Places (POST /v1/commons/known_places/multi_upsert) and Create Known Places (POST /v1/commons/known_places/multi_create) API operations incorrectly required the location ID to be specified when a valid qualifier for that location was included in the request payload. Calls specifying locations with valid qualifiers (and no IDs) now execute correctly.

- WFD-11250* Multiple Time-off Requests (TORs) could be made for same day, even though request subtype transition configuration should have prevented it.
- WFD-11140* Randomly, a "Connection Lost" error appeared and users needed to restart their session.
- (This issue was first resolved for UKG Dimensions R7.)
- WFD-11121* The following error appeared in multiple error logs in the IDP40 identity provider configuration:
- "Alert] : DimCritical : P1 : Nginx ILB : No live upstreams while connecting to upstream".
- WFD-11105* Request for the removal of the following unused Function Access Control Points from **Manager - Common Setup > Brazil Device Setup**:
- MobileTime® > Access to MobileTime® Gatekeeper**
 - MobileTime® > Access to MobileTime® Configuration**
- WFD-11088* Admin Delegation could not delete existing delegations for terminated managers.
- WFD-11056* When attempting to start a delegation process, users received the error:
- "Error This task has failed runtime validation and cannot be completed. Contact your system administrator."
- WFD-11017* An integration that was started in Boomi failed with the following message:
- "502: Bad Gateway error".
- WFD-10966* A known place was configured with a 44m radius. Although employees were issuing mobile punches well within this radius, the punches were being marked as outside the geofenced area.
- WFD-10882* A tenant in the production environment encountered blocking on `getNewSequenceValues`.
- WFD-10862* A replication lag issue was encountered due to slow recovery speed on all three standby nodes of a database server.
- WFD-10787* The `/api/authentication/token/revoke` API failed to revoke a token. The token could be used successfully after revocation.

(This issue was first resolved for UKG Dimensions R7.)

WFD-10724 When a batch task was added to a scheduled event, the event remained active in Event Manager even after the batch event and task was inactivated.

WFD-10572 Scheduled integrations did not send email notifications when integration runs started or completed.

WFD-10531 When users edited an event in the Event Manager and then saved it, Event Manager would automatically trigger it, and it could be seen as a running job in the Batch Event List in **Application Setup > System Configuration**.

WFD-10061 In the mobile app, the geofencing out-punch that was recorded for a non-home location was being placed in the in-punch cell in the timecard.

WFD-10002 Multiple issues were encountered in the Rabbit MQ message broker. They were triggered with the following message:

"ERROR ** mnesia_event got {inconsistent_database, running_partitioned_network".

WFD-99820 In **Application Setup > Common Setup > Batch Processing**, the box that contains the events is too small; long names could not be displayed in full. Further, there is no hover-over option and no scroll bar that a user can slide to see the full name. It is difficult to identify events when the names of several events have long names that start with the same string of characters.

WFD-99661 A long-running SQL statement on a database server was causing batch jobs to take too long to complete or not to complete at all.

WFD-99658 When an Organizational Map was updated, the update was visible followed by multiple *CacheNotificationProcessingThreads*. These threads continued to block other processes for over 1 minute and seemed to be causing performance issues.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-11620 After an express upgrade to a WFM configuration, older nodes were not terminated and still appeared in the ILB. This fix provided a script that returns the current deployments and ILB configurations and checks for any discrepancies between them.

WFD-9817 Tenant provisioning fails while deploying reporting services with the following error:

"Reports failed to Clone. WFP-114244 SystemLogin 7010 Improper Authentication information supplied."

WFD-8563 It took an unacceptable amount of time for a manager to load employee time-off requests into Control Center.

Scheduling

WFD-101405 Users were unable to edit shift templates in Application Setup after an upgrade to R7. When users tried to edit an existing shift template that included a Labor Category transfer, they received the error:

"Page not found The requested URL was not found on this server."

Also, when users attempted to apply a shift template that included a Labor Category transfer in Schedule Planner, the transfer was no longer present after the shift was saved.

WFD-103148 Employee visibility periods kept "dropping" which prevented employees from self scheduling and requesting timeoff.

WFD-101172 Users were unable to assign new locations to Schedule Generator Strategies, Location Profile, and Coverage Counting if they were previously assigned to an end-dated location.

(This issue was first resolved for UKG Dimensions R7.)

WFD-101150 In R7, the Create or Update Persons (POST `/v1/commons/persons/multi_upsert`) API operation began validating the Predictive Scheduling System Setting when the `predictiveSchedulingEligibilityList` property was passed in the request payload. Prior to R7, this validation did not occur. To ensure backwards compatibility, the validation introduced in R7 has been removed, and request payloads with this property included will not fail when the Predictive Scheduling system is not enabled.

WFD-100927 An error appeared when any employee accessed or resized the Absence Calendar.

WFD-100924 Notifications were being sent to all employees in the system and were not being refined by the employee group assigned to the manager who created the request period.

WFD-100921 The Create Employment Terms Paycode Edits (PCEs) (POST `/v1/scheduling/employment_terms_schedule/pay_code_edits/apply_create`) API operation incorrectly required a primary job to be specified in the request even when the employee already had a valid primary job.

- WFD-100864** When managers inserted shift templates in the Schedule Planner to create shifts for employees, the resulting shifts were incorrectly being marked as generated by the Schedule Generator when the shift was queried from the Schedule Multi Read API.
- WFD-100759** When viewing the My Schedule Tile on the Home Page, the date format was incorrect for the locale [for example, Month Day - Month Day (i.e. Oct 21 - Oct 27) instead of Day Month - Day Month (i.e. 21 Oct - 27 Oct)].
- WFD-100579** When a schedule pattern was added to an employee or a new schedule pattern was created in Application Setup, the following error appeared:
- "Some Unknown Error Occurred. Error Details Not Available".
- WFD-100502** The Remove Volume Range option in **Application Setup > Staffing Setup > Staffing Matrix** was not functioning.
- WFD-100371** When attempting to specify an End Date for a Workload Pattern, the following error appeared:
- "Error Some Unknown Error Occurred. Error Details Not Available".
- WFD-100304** The Workload Planner data did not match the Schedule Planner for a specific metric.
- WFD-100195** When more than one type of time-off was scheduled for a specific day, the My Schedule tile displayed the time-off entries as overlapping each other, causing them to be unreadable.
- WFD-100036** The Predictive Scheduling batch job (`SBP_CONFIGURATION`) was being run by the system even though the Predictive Scheduling global system setting and FAP control points were not enabled.
- WFD-99825** When the Call Log was opened in the Schedule Planner for All Employees/ All Jobs, not all of the log entries were displayed. In addition, when the sort order of a column was changed, the log entries were not grouped correctly.
- WFD-99703** When a manager ran a Call List Procedure Set that contained the Call Outcome rule that sorts in ascending order, employees who had outcomes incorrectly appeared at the top of the list instead of at the bottom.
- WFD-99694** The Retrieve Requestable Open Shifts (`POST /v1/scheduling/employee_open_shift_requests/open_shifts/multi_read`) API operation now returns a clear error message instead of a null pointer exception when a resource is not found.

- WFD-99603** The Staffing Plan report did not accurately reflect the hours that an employee was scheduled to work.
- WFD-99481** When individual Availability types were selected in Show/Hide in the Schedule Planner, the selections were not being saved after logging out of the system and logging back in.
- WFD-99129** Users were unable to load a Calendar or manager schedule when a Time-off Request (TOR) was auto-approved in case that no reviewer was found.
- (This issue was first resolved for UKG Dimensions R7.)
- WFD-11623** When adding a new schedule tag, the following error appeared:
- "Database error during processing of task class com.kronos.scheduling.widget.managerschedule.impl.task.SaveTask, Exception :org.springframework.dao.DataIntegrityViolationException".
- WFD-11601** When the Schedule Planner was opened with a specific Dataview assigned, the following error occurred:
- "Invalid data supplied for request, incorrect data type used."
- WFD-11600** The Update Workload Weights or Update, Lock, or Unlock Workload Volumes (POST /v1/scheduling/volume/apply_update) API operation now handles certain error conditions gracefully and no longer throws a null pointer exception.
- WFD-11587** High CPU usage occurred on seven nodes.
- WFD-11574** When changing Workload values in Workload Planner, the following error appeared:
- "ErrorOrgNode(s) not found for reference(s):403".
- WFD-11570** Predictive Scheduling Rules for a shift, which were added using Shift Profile Sets, were not producing the expected results.
- WFD-11558** The Retrieve Shift Cover Requests (POST /v1/scheduling/employee_cover_requests/multi_read) API operation incorrectly returned a null value for the recipient qualifier. The operation now returns the correct value.
- WFD-11543** A hidden Paycode associated with a Holiday did not prevent the Holiday from being displayed in

the timecard as it did for UKG Workforce Central.

WFD-11516 When the API operation `v1/commons/persons/multi_upsert` was used to import or update employees and an employee's schedule pattern was deleted, not all of the related schedule items were also deleted as expected.

WFD-11497 Adding a Budget Workload Pattern overwrote the Plan Workload Pattern without a warning message in Workload Planner.

WFD-11482 The Coverage Variance by Zone report failed, and included the following message:

"KSS_Planned_Coverage does not exist."

WFD-11467 The Update Rule Set Assignments for Multiple Employees (POST `/v1/commons/persons/schedule_rule_sets/multi_upsert`) API operation incorrectly returned an error when the start of an assignmentSpan was equal to the effectiveDate.

WFD-11441 The following problem was occurring when using APIs to send leave information to update schedules and create open shifts.
There were multiple steps in the integration; the first call creates an Open Shift plus the existing shift is modified. The modified shift is what the second call needs to perform a partial override on. This in turn means that multiple Pay Code Edits have to be done for the same employee, same day, one paycode at a time.
Intermittently these steps failed with the error "*You are trying to update an item that has been modified by another user or process. Reload and try again*" even though the second or third Pay Code Edit was started after receiving a success response from the first API.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-11421 In **Scheduler > Quick Actions - Insert Shift Transfer**, the search did not always return the expected records.

WFD-11416 The Create Employment Term Schedule Pattern (POST `/v1/scheduling/employment_term_schedule_patterns/apply_create`) and the Create Employee Schedule Pattern (POST `/v1/scheduling/employee_schedule_patterns/apply_create`) API operations did not provide resubmittable request payloads inside HTTP status code 207 Partial Success response bodies. These operations have been enhanced with an optional query parameter that allows fully resubmittable request payloads to be passed inside 207 responses.

WFD-11409 The Holiday flag appeared for locations on a day on which no holiday occurred.

WFD-11354 When the rule violation for an expired certification was triggered for an employee, the expiration date incorrectly showed as a day earlier than the actual expired date referenced in their People Record.

WFD-11334 The wrong date selection appeared in a daily overtime schedule rule violation message.

WFD-11330 A procedure set was not sorting by the first option for those without access to entire business structure. Since the user had access to the entire location to which the procedure set was assigned, the sort should have worked properly.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-11314 An "SDM-10017: Organization Map root nodes not found" error appeared for a node.

WFD-11310 Harmonized behavior between the user interface and the Update Certification Assignments (POST /v1/commons/persons/certifications/multi_upsert) API operation such that they both accept an end date of 3000-01-01.

WFD-11306 In schedules, an "Internal Server Error" error appeared when the Target Hours tab was displayed, or the data took a very long time to load.

WFD-11300 When users attempted to submit a Time-off Request (TOR) via an API call to v1/scheduling/employee_timeoff, it failed with a Socket Time Exception or an API Error (timeout).

WFD-11254 The Staffing Plan by Zone report failed to run and the following error appeared when the Interactive format was selected:

"Staffing Plan by Zone Report failed. Error occurred in run report processing".

WFD-11225 When selecting the Target Hours tab in the Schedule Planner, the actual projected and target columns all appeared (incorrectly) as 0:00.

WFD-11212 For a Schedule Rule, Rule Violation was triggered by a non-productive Paycode when it was excluded in the rule schedule rule set.

WFD-11211 When the Staffing Plan by Zone report was run, it timed out after five minutes with an error.

WFD-11208 New Team Definitions did not load employees.

WFD-11195 When edits were made to shifts in the Timecard, the shift labels in the Schedule Planner did not

change as expected to reflect the updated shift times.

WFD-11180 When the Schedule Generator was run using the Optimize Shift Contents context, it did not achieve the labor demand or provide adequate coverage for scheduled breaks.

WFD-11169 When using the effective dating of an Employment Term version, the 'versions' were not using the assigned Work Hour Definitions for Overtime calculation as they should have.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-11164 Employees that worked an overnight shift and were qualified to be counted in a zone by coverage counting were not being included in the Staffing Plan by Zone report.

WFD-11115 When an integration was set up to look back 2 days, the "v1/scheduling/schedule/multi_read" API returned the overnight shift which started on the third day back. When the integration is run for 2 days in the past, an overnight shift on the 3rd day in the past should not be included in the results returned by the API.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-11114 When a manager clicked on the More drop-down for an employee in the returned results in the Call List, the full contents of the drop-down menu did not display without having to scroll.

WFD-11060 A People Import failed with the following error:

"WCO-103289 An unknown error occurred".

Also, this resulted in errors in the Transaction Assistant.

WFD-11030 When using Request to Cover, an error appeared.

WFD-11026 When the Audit tab in the Schedule Planner was opened for a selected employee, no data was displayed until a different employee was selected.

WFD-10990 The Staffing by Zone report incorrectly included open shifts when it should have only contained assigned shifts.

WFD-10973 The Schedule Generator was not covering undercoverage when a Schedule Tag was used. When the engine ran, it created a full transfer shifts to cover fill a coverage gap, causing a 'Minimum Time Between Shifts' warning rule to be violated. Also, when the engine ran, it did not

fill a coverage gap, causing the manager to add a segment tag.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-10965 When the Add Volume option was used in Workload Planner, the Location and Span filters were present, and the appropriate volume amount was selected for the desired budget and date range, the Span filter was not applied. All spans showed the selected budgeted entry, not just the filtered spans.

WFD-10944 The Retrieve Schedule Audits (POST /v1/scheduling/audits/multi_read) API operation has been enhanced to include HTTP status code 207 Partial Success responses when activated with an optional query parameter.

WFD-10857 The Audit Report for System Configuration did not identify changes to Pattern Templates and did not show any data.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-10846 A Scheduling setup thread was running for four Days on the Background Processor (BGP).

(This issue was first resolved for UKG Dimensions R7.)

WFD-10803 When managers applied a leave request on behalf of an employee in the schedule, a "Transaction is not found" error appeared.

(This issue was first resolved for UKG Dimensions R7.)

WFD-10730 The /v1/scheduling/schedule API was being used to apply a cascade pay code edits to the schedule. This API uses the "durationInTime" key which expects the value to be in seconds. When a value was passed that did not translate to a full minute, and the value was passed to the timecard, incorrect totals were calculated in the timecard.

(This issue was first resolved for UKG Dimensions R7.)

WFD-10637 Duplicate Schedule Group assignments were contained in person records for multiple employees.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-10621 When adding values to a Budget Workload Pattern, the screen would "jump around" when using

tab to move to other cells.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-10508 When an employee was newly-assigned to a schedule group with an inheritance pattern, a new shift was created, but the shift with the previously generated schedule pattern was not removed.

WFD-10499 The Employee Certification column in a Dataview did not display certifications that have expired even when the selected date range would include the certification as active.

WFD-10490 When attempting to import an Employment Terms Schedule Pattern via the API, the create API returned "Shift Template not found for reference: 19105" even though it listed the Shift Template in the API response.

(This issue was first resolved for UKG Dimensions R7.)

WFD-10484 Request to prevent employees from submitting a time-off request when it duplicated or overlapped with an existing request that remains effective (specifically with a status of Approved/Cancel Submitted).

WFD-10013 Request for the standard read-only Employee Weekly Schedule Report to display a full week (Sunday through Saturday) for departments, even if no employees are scheduled for one or more days in the week. This would improve the format of the report, and alignment of its columns, for printing and posting.

WFD-9509 Performance of the scheduling KPIs was deteriorating due to the significant disk space that was being consumed by the numerous indexes that were being applied to the Scheduling_kpi_* database tables.

WFD-9172 To allow availability overrides to take precedence over base availability/schedule pattern changes, a new option called **Override current availability** was added to the Shift Builder Criteria configuration. When selected, it allows the batch process to overwrite a manager's manually-entered Availability change – such as an Availability Override, a Pay Code edit with an associated Availability, an Enter Time Off with a Pay Code associated with Availability, or an employee's approved Time-off request with a Pay Code associated with Availability – or an employee's approved Availability Change Request when a Schedule Pattern is rolled out. Managers can also now show or hide availability overrides (displayed with a 45-degree cross-hatch pattern) in the Schedule Planner.

WFD-9162 Users were unable to use private (personal) Hyperfinds when setting up Employee Visibility periods.

Timekeeping

- WFD-101414** When accessing the Unresolved Timecards option from the Manage Timecards tile, some of the timecards only had exceptions (for example, Excused Absence) that had already been resolved and should not have been included in the unresolved group of timecards.
- WFD-101277** Following an upgrade to R7, when managers used the Weekly Close Process Dataview, the following message appeared:
- "Data within Actual Hours Worked cannot be retrieved. Contact your system administrator."
- (This issue was first resolved for UKG Dimensions R7.)
- WFD-100977** Many batch jobs for "Exception_tile_data_sync_batch_request" were listed in the Batch Job List and caused other batch jobs to process very slowly.
- WFD-100948** The user interface text for the Transfer Rule option "Scheduled transfer elements **have** priority over punched elements" has been corrected to read "Scheduled transfer elements **yield** priority over punched elements".
- WFD-100936** In the timecard, after signing-off a timecard and then removing the sign-off the Audit tab had the incorrect date for "Sign-Off Delete".
- WFD-100174** When punches were imported through the API, system generated punches appeared in the timecard. When the same punches were added manually, system generated punches did not appear in the timecard.
- WFD-100107** A predictive scheduling bonus used a bonus pay code that appeared in the timecard, even though the pay code definition was configured so that the pay code should not be visible in the timecard.
- WFD-99914** In the timecard, after adding a paycode that contained the "£" symbol, when you clicked in the Amount cell the paycode disappeared.
- WFD-99668** After enabling the global system setting for multiple manager roles (`global.peopleeditor.multiplemanagerroles.enabled`), the manager's existing Hyperfind Query for Home Employees was not brought into their initial manager role on the Assign Role Attributes dialog.
- WFD-99662** On the Totals tab in the timecard, when viewing a date range that included the historical date and the effective date of a historical correction, the All Totals data did not show the correct amount for

combined paycode totals.

- WFD-99923** The Person API operations, such as Create or Update Persons (POST `/v1/commons/persons/multi_upsert`), incorrectly allowed inactive Labor Category Entries to be used as Primary Job assignments. Attempting to specify an inactive Labor Category Entry as a Primary Job assignment now results in a error.
- WFD-99817** The Retrieve Timecard Data for Multiple Employees (POST `/v1/timekeeping/timecard_metrics/multi_read`) API operation now correctly rounds hoursAmount inside the actualTotals array.
- WFD-99807** The Daily Cascade Paycode Projected Amount on the timecard did not match the amount on the Totals tab when the paycode amount was 39 minutes or less.
- WFD-99610** When an employee had the “Timecard Edited by Someone Else” timekeeping alert type configured, notifications were also (incorrectly) sent to the employee’s manager.
- WFD-11634** The Paycodes for Timekeeping API resource [including operations such as Retrieve Paycodes as Manager (GET `/v1/timekeeping/setup/pay_codes`)] did not return the analyticCategoryAssignments object in the response even though this object appeared in the response model on the Developer Portal. Operations against this API resource now correctly return this object.
- WFD-11616** A group edit that added the Hours Worked paycode to an employee’s timecard for a date prior to their hire date was completed successfully.
- WFD-11559** When attempting to add Minimum Wage information to an existing Employment Term, the following error message was received even though all three items were specified:
- “Not all of the 3 minimum wage-related items are specified.”
- WFD-11521** The Background Processor (BGP) encountered an exception during totalization and a "java.lang.NullPointerException" error was received.
- WFD-11472** The Bulk Import Paycode Edits (POST `/v1/timekeeping/pay_code_edits/import`) API operation did not allow paycode edits to be imported without associating a time of day with the edit. This operation has been enhanced to allow the following:

- specify applyDate only
- specify startDateTime only
- specify both startDateTime and applyDate

If both startDateTime and applyDate are specified, they must be the same date or the request results in an error.

WFD-11452 When using Move Amount to move 1 hour of time with a cost center transfer, the negative amount taken from the original total did not have the cost center transfer applied, resulting in incorrect totals.

WFD-11451 An employee's base rate was not rounding correctly in People Information. The rate showed as 30.3259 in the employee information summary, but in the **Timekeeping > Timekeeper** section, the rate was incorrectly rounded to 30.32. The wage rounded correctly (30.33) in the timecard.

WFD-11447 In the timecard, the date format in the Target Hours tab did not reflect the user's locale policy. Dates displayed as MM/DD/YYYY instead of DD/MM/YYYY.

WFD-11401 A performance issue occurred; CPU usage was below threshold (at 100%) for all nodes in cluster. It was taking over 30 minutes for the background processor to process a single employee.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-11386 Attestation questions and answers submitted by an employee when they punched in were not included in the Attestation Dataviews.

WFD-11370 In People Information, when attempting to assign attributes to a manager role, users were unable to save the record.

WFD-11364 When viewing My Timecard on an iPhone and selecting a date, the text shade for punch times was very light and could not be read.

WFD-11362 After changing the department of a job on the business structure, and then creating a Hyperfind to find employees in the new department, an incorrect list was returned.

WFD-11346 The timecard opened slowly for date ranges in the past, or errors appeared.

(This issue was first resolved for UKG Dimensions R7.)

WFD-11335 When attempting to sign-off an employee's timecard, the following error was received even after all exceptions had been justified:

“The timecard cannot be signed off because it contains one or more violations: Unexcused Absences.”

WFD-11325 When attempting to open any employee timecard, the following error appeared:

“Error WFS-104701 WorkRule not found. Reference:1211”.

WFD-11312 The Retrieve Timecard as Employee (GET /v1/timekeeping/employee_timecard) and Retrieve Timecard as Manager (GET /v1/timekeeping/timecard) API operations incorrectly threw HTTP status code 500 Internal Server Error responses when an invalid selection was specified in the "select" query parameter. These API operations now throw the correct error.

WFD-11261

(This issue was first resolved for UKG Dimensions R7.)

WFD-11233 The Exceptions report did not contain any data for the selected timeframe, even though there were exceptions during the timeframe.

WFD-11221 Performance issues occurred with /wfc/restcall/v1/timekeeping/setup/employment_terms API calls due a large number of duration Paycodes.

(This issue was first resolved for a UKG Dimensions R6 update.)

WFD-11220 An employee was excluded from totalization due to an exception encountered during totalization.

WFD-11190 The Retrieve Employee Groups (POST /v1/commons/employee_groups/multi_read) API operation did not return the laborCategoryProfileRef and orgMapGroupRef properties in the response even though they appear in the response model on the Developer Portal. Operations against this API resource now correctly return these properties.

WFD-11182 Operations against the Timecard API resource, such as Retrieve Timecards as Manager (POST /v1/timekeeping/timecard/multi_read), were not always correctly handling auto-resolved exceptions, and the operations would fail. These operations now correctly handle auto-resolved exceptions.

- WFD-11176** The business structure location an employee's primary job was assigned to had expired. After the expiration, timecard data showed a historical correction adding a punch span of 9 hours, but the Historical Corrections tab did not contain any data. Now, The Historical Corrections tab will show the complete transfer including the job while the job is active, and the Location and Cost Center (if linked) starting from the day when the job expires.
- WFD-11127** The Create Labor Category List Assignments (POST `/v1/commons/labor_category_list_assignments/multi_create`) API operation incorrectly threw "An Internal Error Has Occurred" when the specific orgNode qualifier was not valid. The operation now responds with a specific error description.
- WFD-11123** The Update Labor Category Lists (POST `/v1/commons/labor_category_lists/multi_update`) API operation incorrectly threw "An Internal Error Has Occurred" when the entryList array was omitted from the request payload. The operation now responds with a specific error description.
- WFD-11120** For a shift that occurred when daylight savings time was meant to occur, an employee punched out early at 10:00 PM for an 8:00 PM-4:00 AM shift, but only the hours of 10:00 PM-1:00 AM were auto-resolved to the Unpaid Paycode. The remainder of the shift was not auto-resolved.
- WFD-11107** The Bulk Accrual Payout (POST `/v1/timekeeping/accruals/payouts`) API operation did not allow increments of less than 1, which does not match the way the Accrual Policy behaves. The API behavior now allows increments of less than 1.
- WFD-11034** When viewing a pay rule configuration, a holiday that was assigned to the rule was intermittently unassigned on the Holiday Credit tab.
- WFD-11018** In the timecard, after selecting a transfer and then clicking away from the Transfer cell, the transfer disappeared and could not be saved.
- WFD-10941** The Background Processor excluded several employees from totalization. Resubmitting the employees in **Application Setup > System Information > Background Processor** did not correct the issue.
- WFD-10860** The Background Processor (BGP) failed with the following exception:
- "WTK-90150 The BGP can not schedule the next totalization at a time in the past, employee... time... The BGP will not complete this process."
- WFD-10804** An auto-resolved exception caused an additional meal deduction to occur, resulting in incorrect pay for the employee.

- WFD-10785** When adding a duration paycode to the schedule for the second half of a shift, the timecard added the paycode to the first half of the shift.
- WFD-10781** The Retrieve Timecards as Manager (POST /v1/timekeeping/timecard/multi_read) API operation would refuse to return paycode edit data that involved end-dated business structure locations. The operation now correctly returns the data.
- WFD-10735** Many employees had the incorrect labor category for regular shifts that did not have transfers.
- WFD-10707** In the timecard, after a manager marked an exception as reviewed and saved, the following error message appeared:
- “Error Job could not be found, or you do not have access rights to it.”
- Now, the manager (who does not have access to the transfer job associated with the punch or pay code edit) would be able to mark an exception as reviewed.
- WFD-10623** When running a person import integration, some records failed with the following error message related to the primary job assignment:
- “Gaps of time between date ranges are not allowed - Expiration: 1/14/2008, Effective: 6/07/2020.”
- WFD-10653** For employees with daily attestation who worked a third shift in a day, they were not prompted to approve the punches for their third shift.
- WFD-10549** The Background Processor (BGP) encountered an exception during totalization and the following error message was received:
- "java.lang.NullPointerException".
- WFD-10483** An employee received an invalid missed punch exception when punching out at the timeclock. The invalid exception also incorrectly prompted the employee with an attestation message about the missed punch.
- WFD-10471** An employee was scheduled to work 7:00 PM-7:00 AM (with pay from schedule), but they changed the system generated out punch from 7:00 AM to 9:00 AM in the timecard. After clicking Calculate Totals, the 9:00 AM out-punch appeared on the next line and a missing i- punch also appeared.

WFD-10450 When using a cascading policy to deduct hours from different accrual balances, the cascading policy configuration was not followed correctly and an error message was incorrectly received.

WFD-10279 In the timecard, after adding a cost center transfer the totals incorrectly used the employee's home cost center instead of the transfer cost center.

WFD-10271 For request subtypes that were configured to use a normal day pay code or a cascading day pay code, the results in the Totals and Accruals tabs in the timecard were inconsistent.

WFD-10240 Intermittently, the punch for "Clock Out 180 Minutes" was successful but the Attestation question did not appear.

(This issue was first resolved for UKG Dimensions R7.)

WFD-10196 After updating the Allocation Percent and the Labor Category Entries for a percent allocation rule trigger, the following error message was received:

"Exception: WFP-00474 Job could not be found, or you do not have access rights to it."

WFD-10131 The Background Processor failed to totalize employees due to a foreign key violation:

"SQL statement failed due to foreign Key. Please contact your system administrator."

WFD-9843 Overtime hours added to the schedule using a duration Paycode were incorrectly calculated in the timecard as unscheduled hours.

Universal Device Manager

WFD-101430 Kronos InTouch DX was not listing all available jobs

WFD-100791 Person Import performance has been improved to be scalable for a large number for employees (for example, over 250,000). Previously it took several hours for an import for the full population to complete.

(This issue was first resolved for UKG Dimensions R7.)

WFD-11339 A java.lang.NullPointerException occurred in logs from the UDM service.

(This issue was first resolved for UKG Dimensions R7.)

WFD-11332 All hourly employees at a facility did not receive overtime pay. It was noted that in the Combination Rules, the overtime zone was removed.

Adding an Exempt Paycode Distribution should not have affected Pay rule assignments (relevent to the Paycode distribution configuration) that already existed.

WFD-11080 Users were unable to delete a device from UDM when assigned a tag.

WFD-11041 Users were unable to add/Edit Work Rule definitions.

(This issue was first resolved for UKG Dimensions R7.)

WFD-10866 UDM Clock Profile changes were not saved when the radio button for Single Device was selected.

WFD-10824 Users were unable to process duration type Paycodes on a device. The following error appeared on the device when attempting to edit a duration type Paycode:

"WTK-125109 For duration paycode edit, amount value must be blank."

WFD-10283 Attestation Offline pages listed a "Remote Server Not Confirmed" error when a Leave Server was down. Both online and offline Attestations were prevented.

WFD-9945 When employees deleted a schedule shift, it still appeared on an Kronos InTouch DX device.

Work

WFD-144718 The following issues have been resolved:

- The daily Utilization report was including the next day.
- A daily Dataview was incorrect when multiple day-divided data was involved.

WFD-101222 Many employees (for example, 170) werre stuck and could not be totalized.

WFD-100907 The Retrieve Activity Totals for Multiple Employees (POST /v1/work/activity_totals/multi_read) API operation did not always return all valid Work activity totals. Totals are now returned correctly.

WFD-11536 Activities were creating phantom punches incorrectly for previous pay period timeframe.
